# 1. Purpose of Report

1.2 This report outlines the data and background to Complaints, Misconduct and other matters that have been processed in the quarter 1 October to 31 December 2013 by the Professional Standards Department.

The report follows the agreed format required by the Police and Crime Commissioner and informs the Police and Crime Commissioner of the work being conducted; the paper also provides details of finalised cases.

# 1. SIGNIFICANT/HIGH PROFILE CONDUCT AND COMPLANT CASES

### **NEW CASES**

### Independent Police Complaints Commission (IPCC) Supervised Investigation

It is alleged that an officer inappropriately disclosed police information.

The officer is under suspension.

# **Professional Standards Department (PSD(Investigation**

An officer has been charged with illegal possession of firearms and is to appear at Ipswich Crown Court on 7 March 2014.

The officer is under suspension.

### **PSD** Investigation

An officer is the subject of an off duty assault allegation. The officer appeared at Ipswich Magistrates Court on 15 January 2014 charged under Section 4 Public Order; the case was adjourned.

#### **PSD** Investigation

A complaint has been made that an officer sent inappropriate communications to a female after attending her home to deal with an incident.

### **PSD** Investigation

An investigation is ongoing into allegations that a police staff member was in possession of indecent images.

The member of staff is under suspension.

### **CASES PREVIOUSLY REPORTED**

# **PSD Investigation**

A member of police staff has accessed and viewed a large quantity of records on Essex Police System and PNC relating to their family, friends and associates.

The member of staff is under suspension.

Update: Crown Prosecution Service charging advice has been sought.

#### **PSD** Investigation

It was alleged that an officer used excessive force on a youth after a criminal damage incident. The PC appeared at Ipswich Magistrates on 17 October 2013 and the case was dismissed.

Update: A gross misconduct hearing will be held.

### IPCC Supervised investigation

An allegation has been made that officers unlawfully entered a residence and whilst arresting the occupant used excessive force, resulting in a broken wrist.

Update: The investigation is ongoing.

# **PSD** investigation

It is alleged that an officer accessed and disclosed police information regarding an incident involving a relative.

Update: A gross misconduct meeting is to be held.

# **IPCC Independent Investigation**

A male was found deceased shortly after leaving police custody; as this was a death following police contact it was referred to the IPCC.

Update: The IPCC investigation is ongoing.

# **IPCC** Independent Investigation

Police attended a concern for welfare after which the female occupant died; as this was a death following police contact it was referred to the IPCC.

Update: The IPCC investigation is ongoing.

#### **IPCC Independent Investigation**

A male died shortly after being arrested for non payment of a fine; as this was a death following police contact it was referred to the IPCC.

Update: The IPCC investigation is ongoing.

#### **PSD** Investigation

An officer is alleged to have has an inappropriate relationship with a witness.

Update for January 2013: A gross misconduct hearing is to be held.

#### **IPCC Supervised investigation**

An officer is under investigation for abusing his position to form relationships with a number of females. It is also suspected that has carried out police checks without a policing purpose.

The officer is under suspension.

Update: A file has been submitted to the Crown Prosecution Service.

#### **IPCC Supervised Investigation**

A complaint was made about the investigation of a sexual offence.

Update: An appeal has been made by the complainants to the IPCC.

#### **PSD Investigation**

An officer is under investigation for sexually assaulting a female suspect; a second victim made similar allegations.

The officer is under suspension.

Update: The officer is due to attend trial at Ipswich Crown Court on 31 March 2014

#### **IPCC Independent Investigation**

A complaint was made that a sexual offence was investigated poorly.

Update: Three officers are to attend a gross misconduct hearing, subject to any appeal, other officers are to receive management action.

#### 2. SUSPENDED OFFICERS AND POLICE STAFF

As at 31<sup>sn</sup> December, in addition to the officers and staff members referred to in Part 1, one other member of police staff was under suspension in circumstances which are neither significant or high profile.

#### 3. APPEALS MADE TO THE IPCC

- (1). Where a complaint has been investigated by the Professional Standards Department, the complainant has a right of appeal to the IPCC if they are dissatisfied with the complaint investigation and/or its outcome.
- (2). Where a complaint has been dealt with using the local resolution process, the complainant has a right of appeal to the IPCC should they be dissatisfied with the process or the actions taken to resolve the complaint. This only applies to complaints recorded before 22 November 2012; for complaints recorded after that date, the appeal authority is the Chief Officer.
- (3). Matters submitted to the Professional Standards Department as complaints are reviewed and assessed to determine whether or not they should be formally recorded as a complaint. In cases where it would not be appropriate to record the matter as a complaint, the decision is explained and the person is advised of their right to appeal against the non recording of the complaint to the IPCC.

The IPCC remain 36 weeks behind in handling appeals. This means that the investigation appeals received in the period (6) have not yet been allocated to a casework manager. Only one appeal was upheld in the guarter and this was against non recording.

#### APPEALS MADE TO THE CHIEF OFFICER

Following the implementation of the Police Reform and Social Responsibility Act, appeals for issues which are not serious in nature, e.g. criminal matters, issues likely to result in disciplinary proceedings or those which have been subject to a mandatory referral to the IPCC are now handled by the Professional Standards Department. The numbers registered in the last quarter are shown in the table below.


