1. Purpose of Report

1.2 This report outlines the data and background to Complaints, Misconduct and other matters that have been processed in the period 1 October to 31 December 2014 by the Professional Standards Department.

The report follows the agreed format required by the Police and Crime Commissioner and informs the Police and Crime Commissioner of the work being conducted; the paper also provides details of finalised cases.

1. <u>SIGNIFICANT/HIGH PROFILE CONDUCT AND COMPLAINT CASES</u>

NEW CASES

IPCC Independent/Managed Investigations - Operation MAPLE

Concerns were raised about the performance of an Investigation Team in the North of Essex which has prompted a review of current cases handled by that team. To date 30 cases have been referred to the IPCC who have decided to conduct an independent investigation into two cases and for the remainder to be part of a managed investigation.

One officer has been suspended and 11 Officers have had restrictions placed on them and deployed to other postings pending an investigation.

IPCC Independent Investigation - MI/218/14

A referral was made regarding the police response to reports of a male walking on the A12. The man died as a result of a multiple vehicle incident.

IPCC Supervised investigation MI/202/14

A vulnerable female has alleged that in the 1990's she reported a crime and that the investigating officer established a relationship with her. This allegation is subject of an investigation.

PSD Investigation - MI/214/14

A vulnerable female reported that an Officer has failed to investigate an incident properly or to provide appropriate safeguarding. This was referred to the IPCC who returned the matter for the force for local investigation.

PSD Investigation - CM/17/14

An officer was arrested by City of London police in connection with a fraud and is on bail until February 2015.

The officer is under suspension.

PSD Investigation - CM/63/14

A Special Constable was arrested by the Metropolitan Police Service following allegations of an inappropriate relationship with a minor in the course of that officer's civilian occupation. This officer has been bailed until February 2015.

The officer is under suspension.

PSD Investigation - CM/110/14

An officer has been arrested for domestic abuse and bailed until February 2015.

The officer is under suspension.

CASES PREVIOUSLY REPORTED

IPCC Independent Investigation - MI/164/14

Members of the public reported that a male was creating a disturbance in the street. The male was restrained by members of the public and subsequently by police and ambulance staff. The male suffered a cardiac arrest whilst being conveyed to the hospital by ambulance. The male died 24 hours later.

Update: The IPCC investigation has been completed and the investigation report is

pending.

IPCC Independent Investigation - C/735/14

A complaint was made from a male youth who alleged that he was assaulted by police resulting in facial injuries whilst he was being searched for drugs.

Update: The IPCC investigation is ongoing.

IPCC Independent Investigation - C/621/14

A complaint was made to police about the harassment of a vulnerable female by an ex partner; a restraining order was in place, however, no arrest was made. The female subsequently made an allegation of serious sexual assault against the ex partner.

Update: The IPCC investigation is ongoing.

IPCC Independent Investigation - CM/93/14

Potential shortcomings have been identified in an investigation and an IPCC investigation has commenced.

Update: The IPCC investigation is ongoing.

PSD Investigation - CM/89/14

Two officers are alleged to have made false entries in a domestic violence report. The officer's had restrictions imposed and a PSD investigation is in progress.

Update: The PSD investigation has been completed and both officers are to attend a Gross

Misconduct Hearing.

IPCC Independent Investigation - MI/171/14

A referral was made to the IPCC as a result of a criminal allegation not being acted upon promptly.

Update: An IPCC investigation has commenced.

PSD Investigation - CM/67/14

It is alleged that a male officer has had inappropriate contact with vulnerable females.

Update: The officer has been suspended and a PSD investigation is in progress.

The IPCC has returned this matter back to force to be conducted as a local

investigation.

IPCC Independent Investigation - PSD Investigation - MI/39/14

Concerns have been raised regarding previous police contact with the suspect in a murder investigation.

The case went to Crown Court on 29 November 2014 and the PSD investigation will be subjudice until the conclusion of the court case.

Update: The suspect was found guilty and sentenced to life imprisonment and an IPCC

independent investigation has commenced.

IPCC Independent Investigation - MI/230/12 - CM/93/14

A male was found deceased shortly after leaving police custody and this was referred to the IPCC as it was a death following police contact.

Two officers are to attend a misconduct meeting on 3 November 2014

Update: The meeting found there was a case to answer and the officers will be dealt with

through management action which will include retraining in custody procedures.

IPCC Supervised investigation CM/44/13

An officer is under investigation for abusing his position to form relationships with a number of females. It is also suspected that has carried out police checks without a policing purpose.

The officer is under suspension.

Update: A guilty plea was entered at Crown Court and a sentencing date is yet to be set

PPU Investigation - CM/43/14

An allegation has been made that an officer had an inappropriate sexual relationship whilst off duty. The officer has been arrested, bailed and suspended. The matter was referred to the IPCC who agreed a local investigation.

Update: The officer is to appear at court in February 2015 charged with making indecent

images of children.

2. SUSPENDED OFFICERS

At the time of submission of this report, 5 police officers and one special constable were under suspension.

3. APPEALS MADE TO THE IPCC

- (1). Where a complaint has been investigated by the Professional Standards Department, the complainant has a right of appeal to the IPCC if they are dissatisfied with the complaint investigation and/or its outcome.
- (2). Where a complaint has been dealt with using the local resolution process, the complainant has a right of appeal to the IPCC should they be dissatisfied with the process or the actions taken to resolve the complaint. This only applies to complaints recorded before 22 November 2012; for complaints recorded after that date, the appeal authority is the Chief Officer.
- (3). Matters submitted to the Professional Standards Department as complaints are reviewed and assessed to determine whether or not they should be formally recorded as a complaint. In cases where it would not be appropriate to record the matter as a complaint, the decision is explained and the person is advised of their right to appeal against the non recording of the complaint to the IPCC.

The lead time for the IPCC to allocate appeals is currently 8 weeks. This means that the cases shown in appeal outcomes (upheld/not upheld) usually relate to appeals lodged in the previous quarter(s).

There is 1 upheld non recording appeal which relates to the force not making a recording decision, rather than the IPCC directing that a complaint be recorded. There was 1 not upheld non recording appeal whilst 5 await adjudication.

APPEALS MADE TO THE CHIEF OFFICER

Following the implementation of the Police Reform and Social Responsibility Act, appeals for issues which are not serious in nature, e.g. criminal matters, issues likely to result in disciplinary proceedings or those which have been subject to a mandatory referral to the IPCC are now handled by the Professional Standards Department. The numbers registered in the last quarter are shown in the table below.
