## 1. Purpose of Report

1.2 This report outlines the data and background to Complaints, Misconduct and other matters that have been processed in the period 1 July to 30 September 2014 by the Professional Standards Department.

The report follows the agreed format required by the Police and Crime Commissioner and informs the Police and Crime Commissioner of the work being conducted; the paper also provides details of finalised cases.

## 1. <u>SIGNIFICANT/HIGH PROFILE CONDUCT AND COMPLAINT CASES</u>

### **NEW CASES**

## IPCC Independent Investigation - MI/164/14

Members of the public reported that a male was creating a disturbance in the street. The male was restrained by members of the public and subsequently by police and ambulance staff. The male suffered a cardiac arrest whilst being conveyed to the hospital by ambulance. The male died 24 hours later.

### IPCC Independent Investigation – C/735/14

A complaint was made from a male youth who alleged that he was assaulted by police resulting in facial injuries whilst he was being searched for drugs.

### IPCC Independent Investigation – C/621/14

A complaint was made to police about the harassment of a vulnerable female by an ex partner; a restraining order was in place, however, no arrest was made. The female subsequently made an allegation of serious sexual assault against the ex partner.

### IPCC Independent Investigation - CM/93/14

Potential shortcomings have been identified in an investigation and an IPCC investigation has commenced.

### PSD Investigation - CM/89/14

An officer is alleged to have made false entries in a domestic violence report. The officer has had restrictions imposed and a PSD investigation is in progress.

# MI/171/14

A referral was made to the IPCC as a result of intelligence which was held on a male not been acted upon sooner. The IPCC have not yet decided on the mode of investigation.

### PSD Investigation – CM/67/14

It is alleged that a male officer has had inappropriate contact with vulnerable females. The officer has been suspended and a PSD investigation is in progress.

### **CASES PREVIOUSLY REPORTED**

### PSD Investigation – CM/54/14

Concerns were raised that an officer was disclosing police information and acting inappropriately on and off duty by making racist and or sexist remarks. The officer was arrested, bailed and suspended from duty.

Update: The officer has resigned and their details have been added to the national disapproved register.

## PSD Investigation - CM/56/14

It was found that a staff member had accessed police information and harassed an ex-partner. A criminal investigation is ongoing and the member of staff has been suspended.

Update: The member of staff has resigned and their details have been added to the national disapproved register.

# PSD Investigation - C/227/14

A complaint was made about how a search for a missing person was conducted, who was found deceased.

Update: The inquest recorded a verdict of natural causes. Of the nine complaint allegations, 6 were upheld. The investigation report made a number of recommendations on resourcing and training and the family are working with Essex Police on developing training packages.

### PSD Investigation – MI/39/14

Concerns have been raised regarding previous police contact in respect of a murder investigation.

Update: The case goes to Crown Court on 29 November 2014 and the PSD investigation will be subject to sub judice until the conclusion of the court case.

# PSD Investigation - CM/22/14

An allegation that an officer has breached the Data Protection Act and Conspired to Pervert the Course of Justice.

Update: The officer has resigned and their details have been added to the national disapproved register.

# PSD Investigation - C/747/12

It was alleged that an officer used excessive force on a youth after a criminal damage incident. The PC appeared at Ipswich Magistrates on 17 October 2013 and the case was dismissed.

Update: A gross misconduct hearing was held and the officer was dismissed without notice and their details have been added to the national disapproved list. The officer appealed against the dismissal and the appeal was not upheld.

#### PSD investigation – CM/62/13

It is alleged that an officer accessed and disclosed police information regarding an incident involving a relative.

A gross misconduct hearing was held and the officer was dismissed without notice and their details have been added to the national disapproved list.

Update: The officer lodged an appeal which was not upheld.

# IPCC Independent Investigation - MI/230/12 - CM/93/14

A male was found deceased shortly after leaving police custody and as this was a death following police contact the case was referred to the IPCC.

Update: Two officers are to attend a misconduct meeting on 3 November 2014

## <u>IPCC Independent Investigation – MI/35/13</u>

A male died shortly after being arrested for non-payment of a fine and as this was a death following police contact it was referred to the IPCC.

Update: The IPCC investigation report has been published which identified some learning points but there was no criticism of Essex Police and or concerns relating to staff conduct.

### **IPCC Supervised investigation CM/44/13**

An officer is under investigation for abusing his position to form relationships with a number of females. It is also suspected that he has carried out police checks without a policing purpose.

The officer is currently suspended from duty.

Update: The case has been scheduled for trial at Crown Court.

# IPCC Supervised Investigation -C/263/13

A complaint was made about the investigation of an offence.

Three officers attended a misconduct meeting and the outcome was that all three officers received a written warning.

### **PSD Investigation C/17/13**

An officer is under investigation for sexually assaulting a female suspect and a second victim made similar allegations.

The officer was dismissed following a gross misconduct hearing for unrelated honesty and integrity failings.

The officer is due to attend trial at Crown Court on 24 November 2014 for sexual assault.

#### **IPCC Independent Investigation**

A complaint was made that a case was investigated poorly.

Three officers are to attend a misconduct meeting on 19 November 2014.

# 2. <u>SUSPENDED OFFICERS</u>

At the time of submission of this report, 5 police officers were under suspension.

### 3. APPEALS MADE TO THE IPCC

- (1). Where a complaint has been investigated by the Professional Standards Department, the complainant has a right of appeal to the IPCC if they are dissatisfied with the complaint investigation and/or its outcome.
- (2). Where a complaint has been dealt with using the local resolution process, the complainant has a right of appeal to the IPCC should they be dissatisfied with the process or the actions taken to resolve the complaint. This only applies to complaints recorded before 22 November 2012; for complaints recorded after that date, the appeal authority is the Chief Officer.
- (3). Matters submitted to the Professional Standards Department as complaints are reviewed and assessed to determine whether or not they should be formally recorded as a complaint. In cases where it would not be appropriate to record the matter as a complaint, the decision is explained and the person is advised of their right to appeal against the non recording of the complaint to the IPCC.

<sup>\*(</sup>The lead time for the IPCC to allocate appeals is currently 14 weeks. This means that the cases reflected in the appeal outcomes (upheld/not upheld) usually relate to appeals lodged in the previous quarters).

There is 1 upheld non recording appeal which relates to the force not making a recording decision, rather than the IPCC directing that a complaint be recorded. There were 2 not upheld non recording appeals.

# **APPEALS MADE TO THE CHIEF OFFICER**

Following the implementation of the Police Reform and Social Responsibility Act, appeals for issues which are not serious in nature, e.g. criminal matters, issues likely to result in disciplinary proceedings or those which have been subject to a mandatory referral to the IPCC are now handled by the Professional Standards Department. The numbers registered in the last quarter are shown in the table below.
