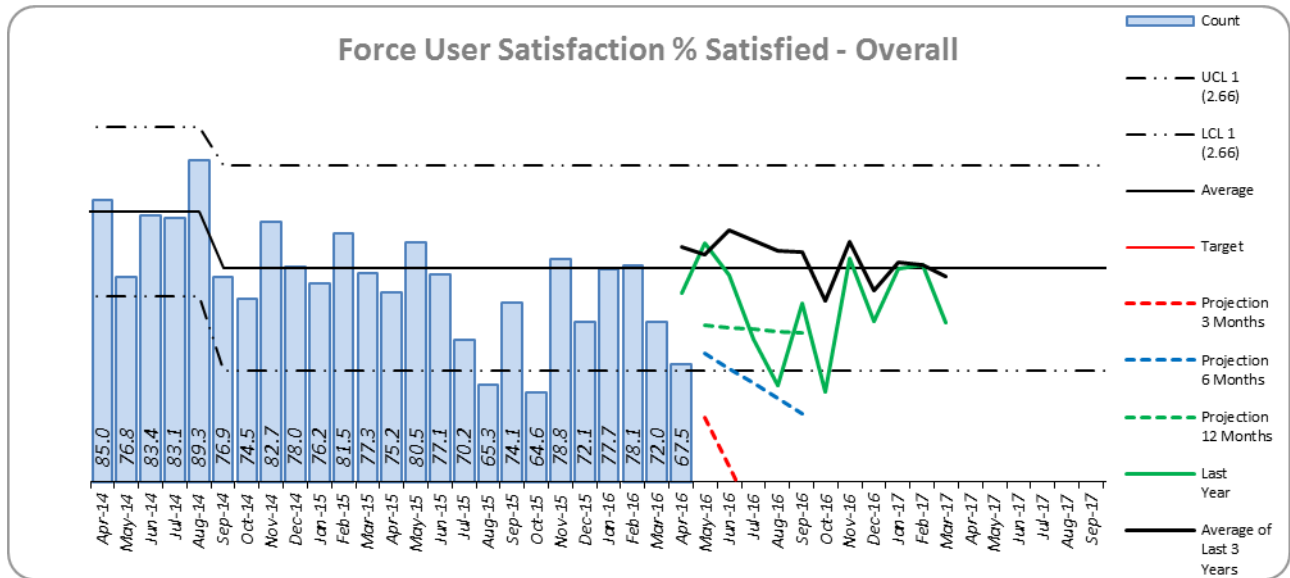

Management Information

The qualifiers used to close the incident as drug/alcohol/mental health-related can be assigned by any authorised person during the 'resulting' or 'closing' process. As a result, a degree of caution has to be used whilst quoting these figures as an accurate representation of policing interaction. These figures are collated from a system that is designed for Command and Control and not one for management information.

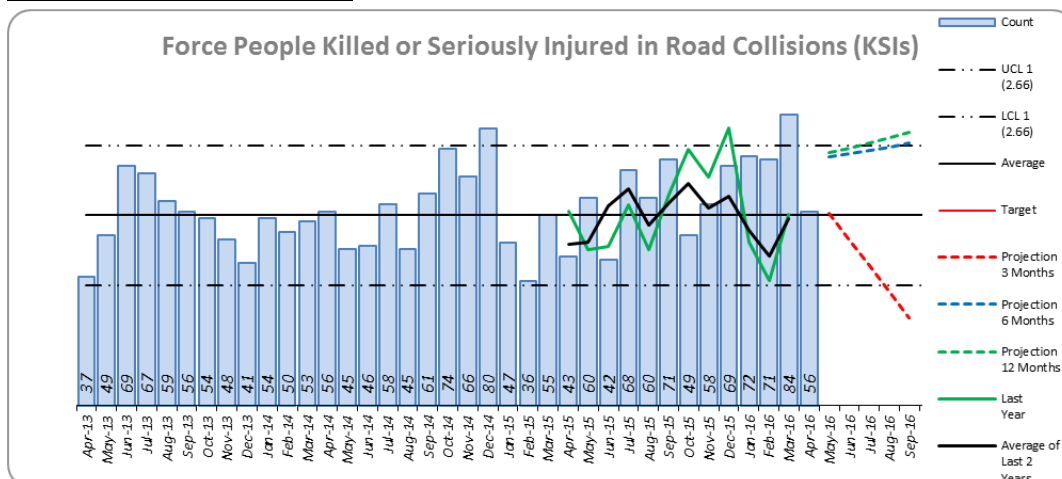

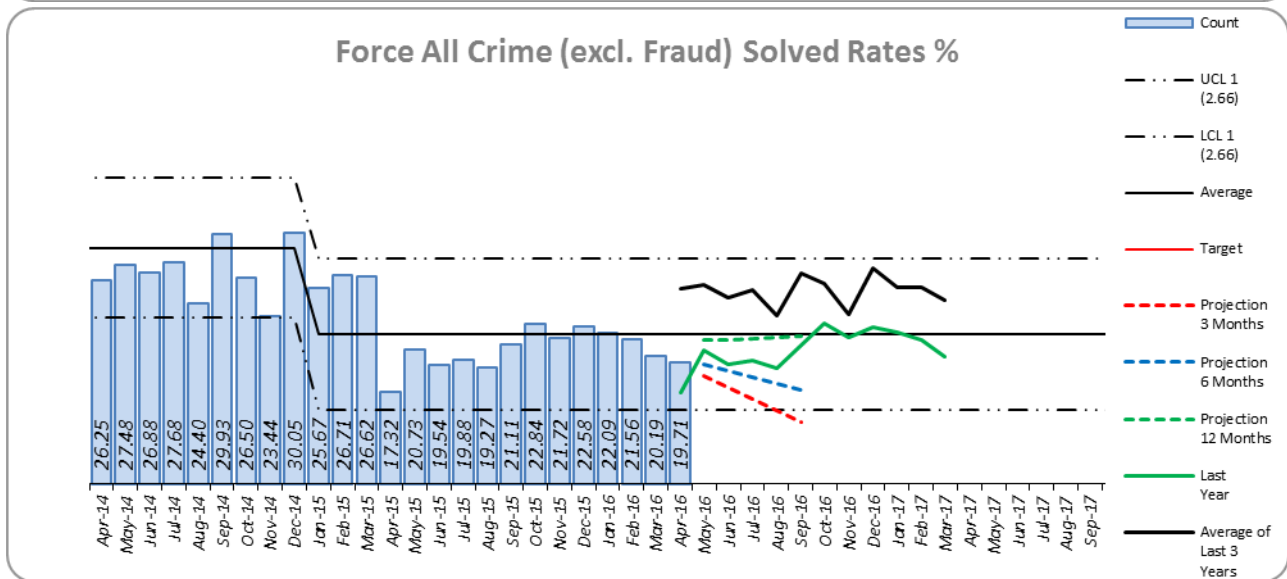
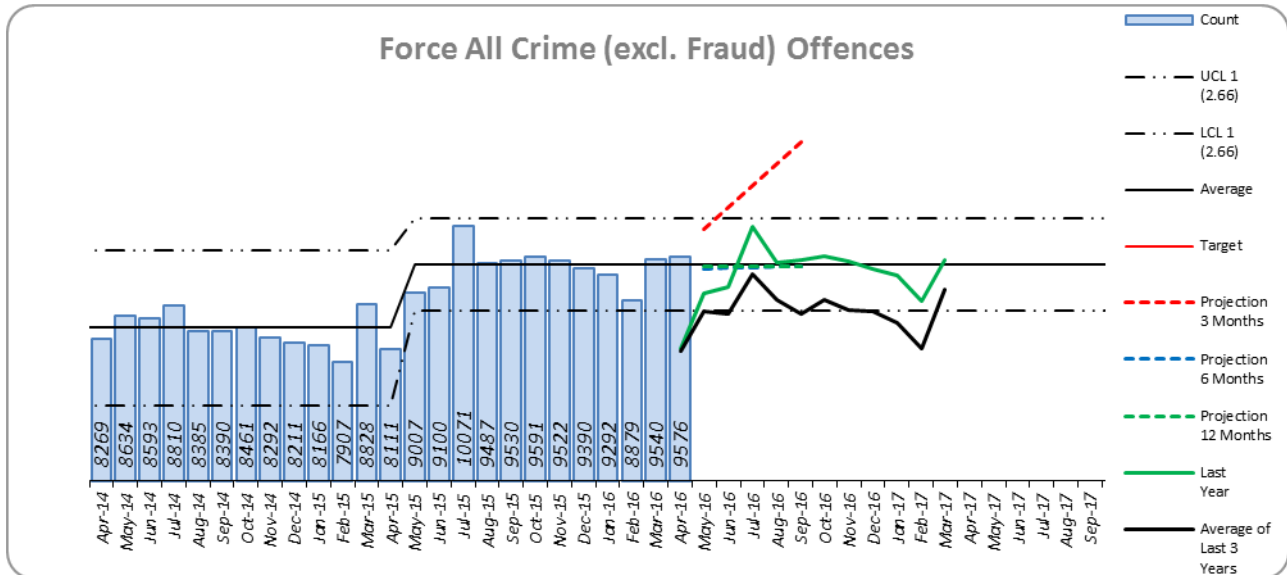

A significant proportion of the savings for 2016/17 have already been achieved and firm plans are in place for the remainder.

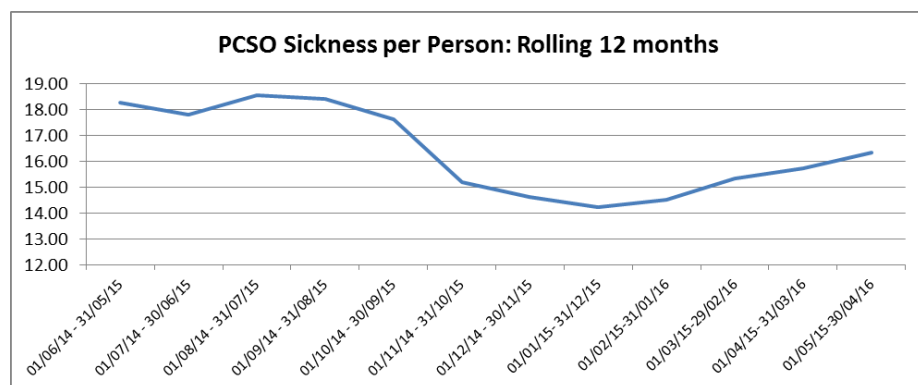
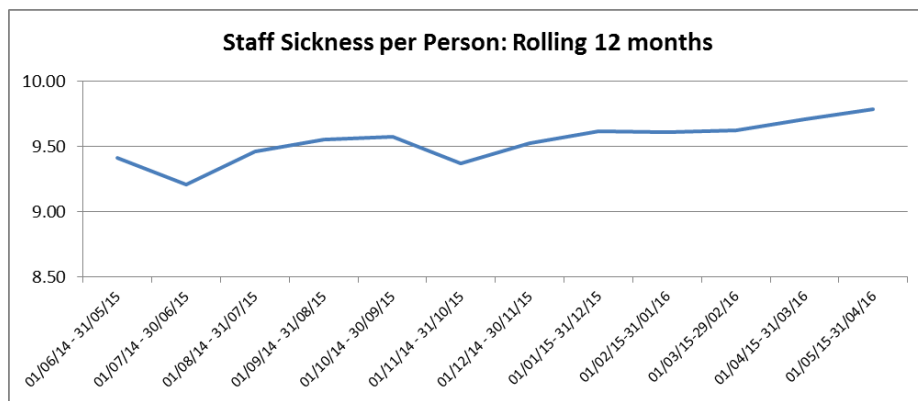
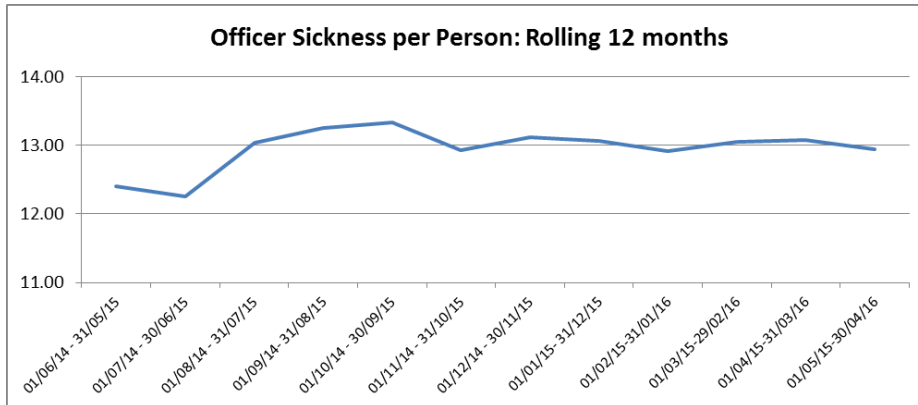
