1. Purpose of report

- 1.1. Commission work to produce geo-demographic analysis of Essex Police data relating to Domestic Abuse
- 1.2. The Essex Police procurement department have been engaged with to establish the most appropriate process for commissioning this piece of work; they have advised the most appropriate approach is as a Single Tender Action to commission Experien.
- 1.3. The results of this analysis will be used by the Force and the OPCC in considering Force and partnership response to Domestic Abuse and the provision of victim services.
