1. Purpose of report

1.1. To seek approval for the allocation of £1,271 in the form of a crime and disorder reduction grant from the Victims Capacity Building Fund to Pontlands Park, whose activities will contribute to the priorities set out in the Police and Crime Plan for Essex. This would secure or lead to securing a reduction in crime and disorder.

We are holding a practitioner's workshop regarding crimes of domestic abuse as part of our continued commitment to assist in reducing domestic abuse across the county and to ensure there is appropriate and timely support for victims of abuse.

- To share an understanding of the service and support provided by Essex Police.
- To raise awareness and understanding of each agencies role and responsibilities.
- To jointly consider how we can work together to improve the services within our organisations to support victims of Domestic Abuse.
- To jointly consider how we remove duplication from DA victim contact and support to assist in improving the service provided.
- To understand the current victim support structures and arrangements within Essex.
