1. Purpose of report

1.1. To seek approval for the allocation of £871 in the form of crime and disorder reduction grants from the New Initiatives Fund (NIF) to Essex Community Foundation (ECF) in support of the priorities within the Police and Crime Plan

2. Recommendations

- 2.1. Approve the allocation of the NIF grant to provide funding for the shortlisted projects within this year's Police Property Act (PPA) Grant schedule in support of local community safety initiatives. The Essex Community Foundation administers the PPA on behalf of Essex Police.
- 2.2. The payment of this grant will be subject to a signed funding agreement.

3. Benefits of Proposal

3.1 Part of the funding will support the Borderline project delivered by Tendring CSP, which is a multi-agency project aimed at changing the lives of young people. It is an early intervention and educational scheme intended to reduce crime and anti-social behaviour, as well as raising awareness of the consequences of crime and has operated successfully for 6 years with an overall success rate of 84%

3.2 The second element of funding will support a gardening service for vulnerable and older residents in Epping Forest. The scheme takes referrals from local Police after burglaries or vandalism has taken place and where it is thought that the state of the garden may be the factor, hence the project will increase community safety and reduce fear of crime.

4. Background and proposal

4.1 Essex Community Foundation administers the Police Property Act on behalf of the PCC. In 2013-14 ECF have made recommendations for the allocation of the £1,669 available from this year's fund. In addition, ECF have shortlisted two further projects for consideration. The PCC has chosen to support these shortlisted projects with funding from the New Initiatives Fund as the aims of these projects match those of the NIF.

5. Police and Crime Plan

- 5.1. Supports priorities in the Police and Crime Plan as follows;
 - Reducing youth offending and youth re-offending
 - Tackling the consequences of drug and alcohol abuse and mental health issues
 - Improving crime prevention
 - Supporting our victims of crime
