**1. Purpose of report**

- 1.1. To seek approval for the allocation of £6,800 in the form of a crime and disorder reduction grant from the New Initiatives Fund to Heybridge & Southminster Parish Councils, whose activities will contribute to the priorities set out in the Police and Crime Plan for Essex.

**2. Recommendations**

- 2.1. Approve the allocation of the New Initiatives Fund grant to Heybridge & Southminster Parish Councils to set-up sports drop-in diversionary projects to reduce anti-social behaviour and low level offending.

**3. Benefits of Proposal**

- 3.1 This intervention will reduce levels of ASB and offending by providing alternative diversionary activity to those at risk of becoming involved in crime and ASB.
- 3.2 The project will build the confidence and self-esteem of those engaged.



