1. Purpose of report

1.1. To seek approval for the allocation of £6,000 in the form of a crime and disorder reduction grant from the NIF to Essex County Council, whose activities will contribute to the priorities set out in the Police and Crime Plan for Essex.

2. Recommendations

2.1. Approve the allocation of the NIF grant to deliver a family Boot-Camp Day as part of the Troubled Families work led by the Essex Family Solutions Teams.

3. Benefits of Proposal

- 3.1 The overall aims of the day will be to promote health and positivity within the mind, relationships and every- day living. It is hoped that this will give the young people and parents some education and learning on how to rebuild family relationships, for parents to take responsibility and be accountable for the behaviours presented by their children and to build on their networks through Community Support. For the young people we will be educating them around crime, enabling them to build on the relationship with their parents in a positive environment and to build on their self-esteem.
- 3.2 The objectives for the day will be:

- To provide parent focus workshops that will include education on duty as a parent/behavioural strategies when living with adolescents.
- Parent- Focused workshops around protecting your mental health and well-being with some mindfulness techniques to cope with every- day life.
- Workshops with young people to develop awareness of own mental health and well- being including drugs and sexual health.
- Education on impact of gang related culture and peer pressure.
- Education on behaviour and consequences and how this can impact into Adult life.
- Families working together as a team to develop and promote their relationships through physical activities.

4.1 The proposal is supported by a detailed application in the required format.

- Reducing Domestic Abuse
- Reducing Youth Offending and Re-offending
