1. Purpose of report

- 1.1. To seek approval for the allocation of £15,000 in the form of a crime and disorder reduction grant from the NIF to Wilderness Foundation for delivery of the Turnaround project.

2. Recommendations

- 2.1. Approve the allocation of the NIF grant for the delivery of the Turnaround project.

3. Benefits of Proposal

- 3.1. The proposal is to deliver the Turnaround project, which is a structured intervention programme aimed at dealing with complex issues that lead to challenging behaviours amongst young people.
- 3.2. Participants are predominantly Not in Education, Employment or Training (NEET) and are referred from Youth Offending Services or Probation. Most referrals display multiple risk factors.

4. Background and proposal

- 4.1 The programme engages with 10 individuals at one time and provides intensive structured intervention programme over a year.
- 4.2 The project benefit from around £53,000 match-funding from a range of organisations

5. Police and Crime Plan

Supports priorities in the Police and Crime Plan as follows;

- Reducing Domestic Abuse
- Improving crime prevention
- Reducing youth offending and youth re-offending
- Tackling the consequences of drug and alcohol abuse and mental health issues
- Ensuring local solutions meet local problems


