1. Purpose of report

1.1. To seek approval for the allocation of £4,620 in the form of a crime and disorder reduction grant from the NIF to London Bus Theatre Company, whose activities will contribute to the priorities set out in the Police and Crime Plan for Essex.

2. Recommendations

2.1. Approve the allocation of the NIF grant to deliver a number of drama workshops and film a full length film featuring young people from deprived areas of Canvey Island.

3. Benefits of Proposal

- 3.1 The project aims to reduce anti-social behaviour and improve life-skills for those at risk of offending or re-offending by providing positive diversionary activity.
- 3.2 In addition to involving around 300 disadvantaged young people in a film-making project, this initiative will also run drama clubs and workshops as well as arranging free cinema trips at times of the year when ASB has traditionally been highest (ie around Christmas and on Bonfire night).

3.3 Some young people will also benefit from arts awards, which provide UCAS points, ensuring the activity gives them better chances to secure places within education.
