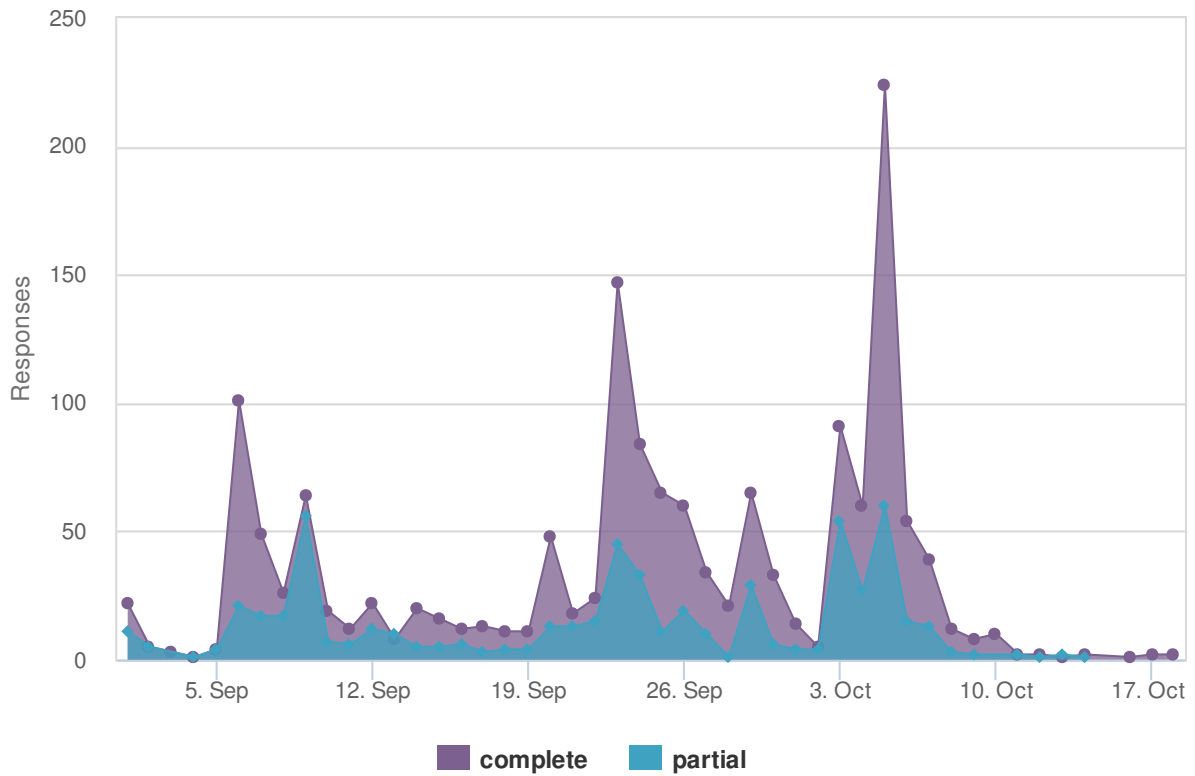

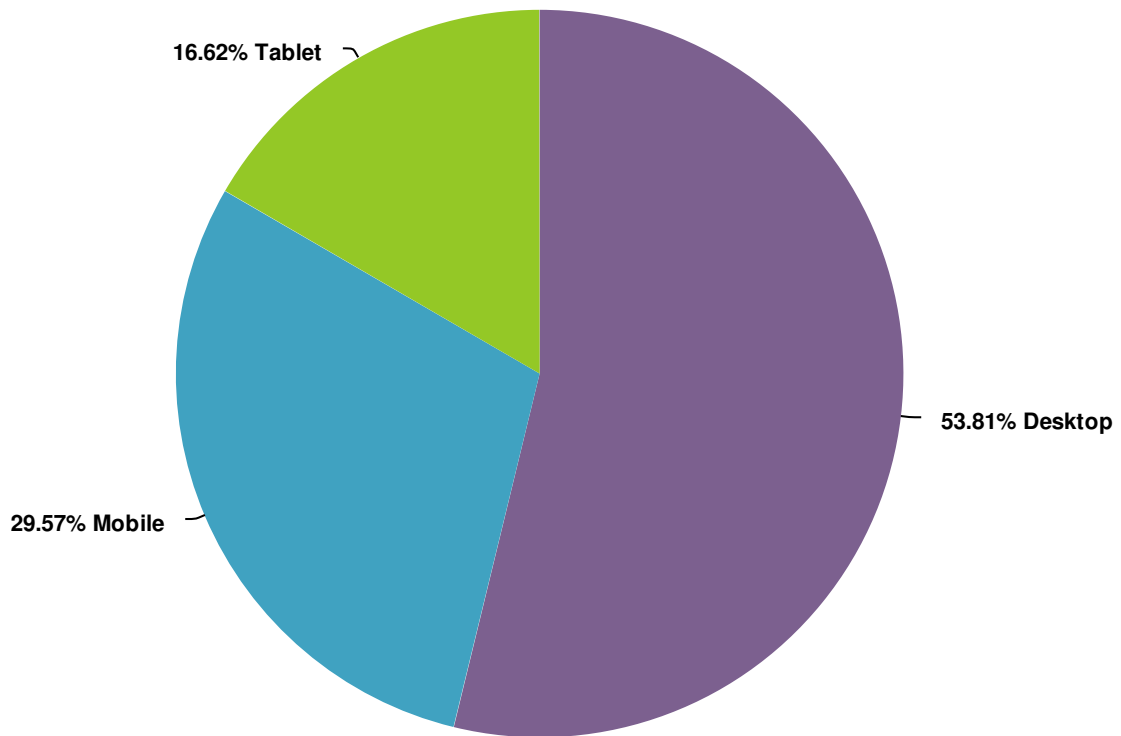

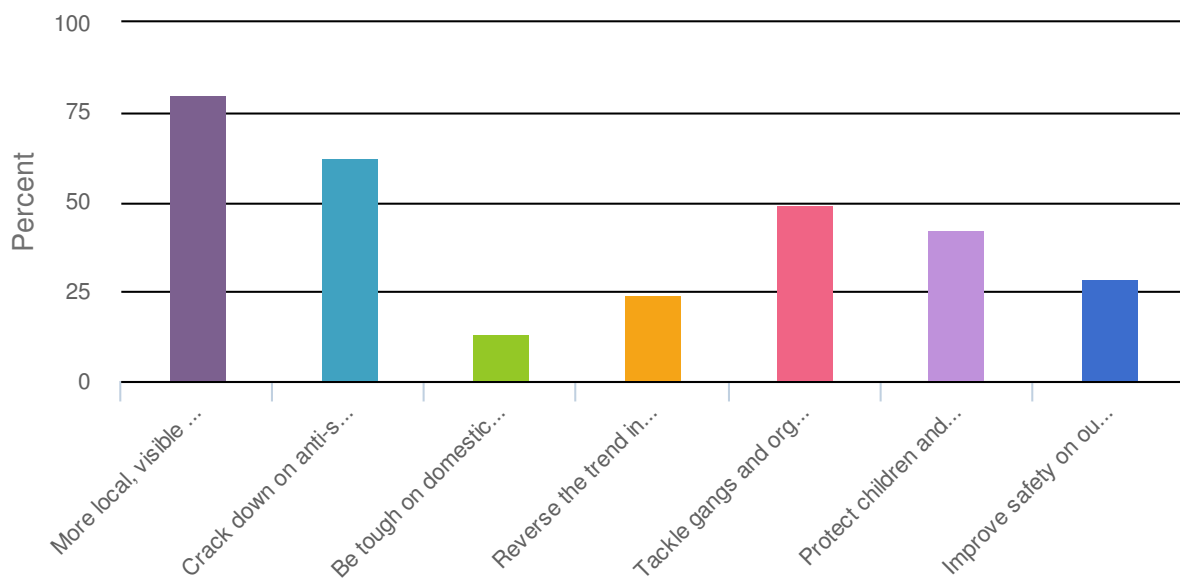

1. The Essex Police and Crime Plan is focused on seven priorities. Please identify the three priorities from this list which are most important to you.

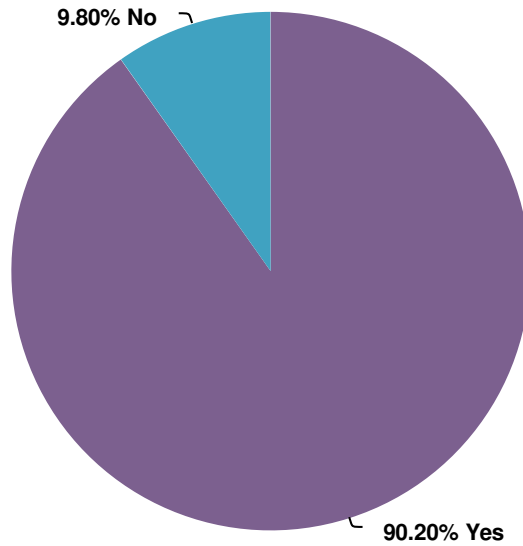

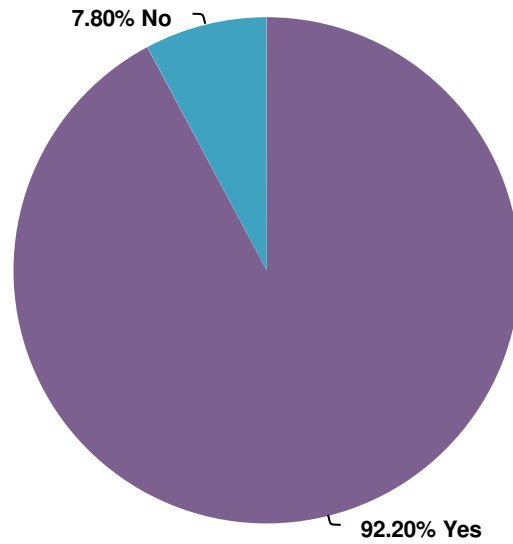

5. We believe ensuring the police are more local, visible and accessible as a key priority will help prevent crime from happening and keep communities safe. Do you agree with the actions proposed?

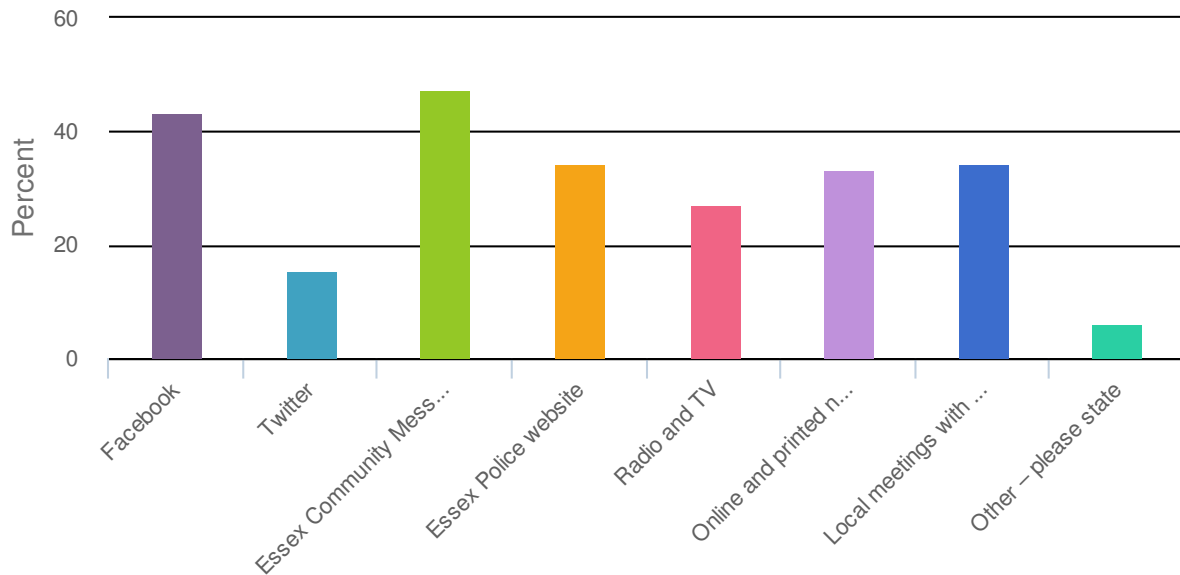

6. How can Essex Police improve local policing in your community?

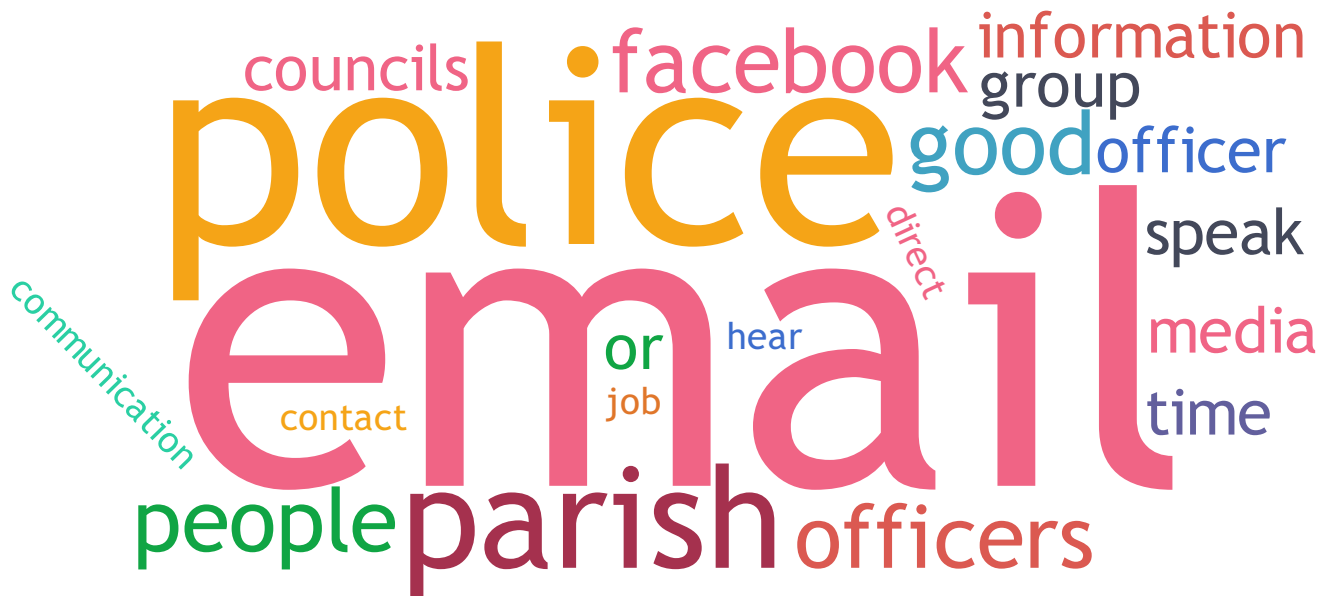

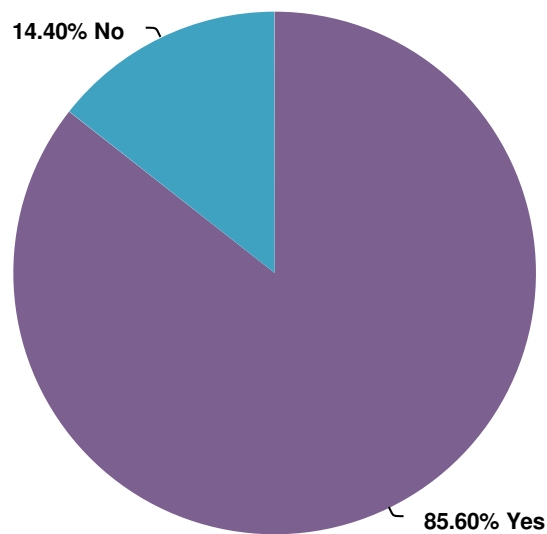

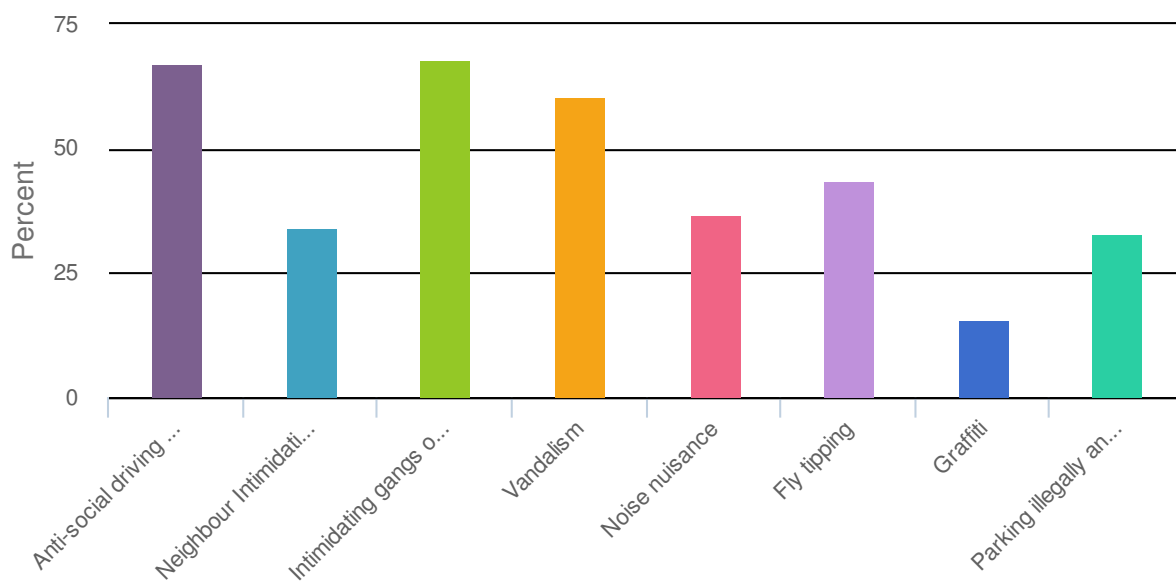

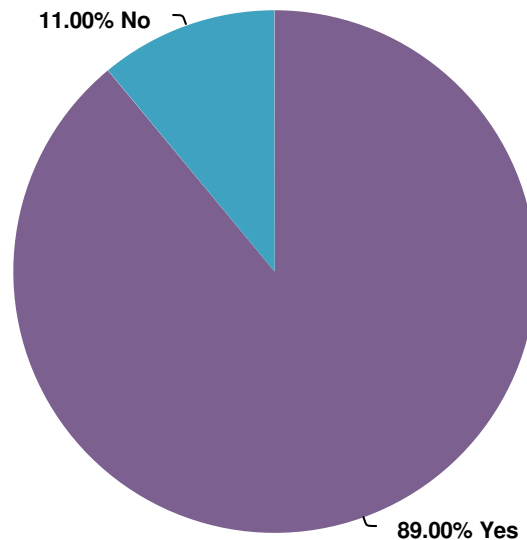

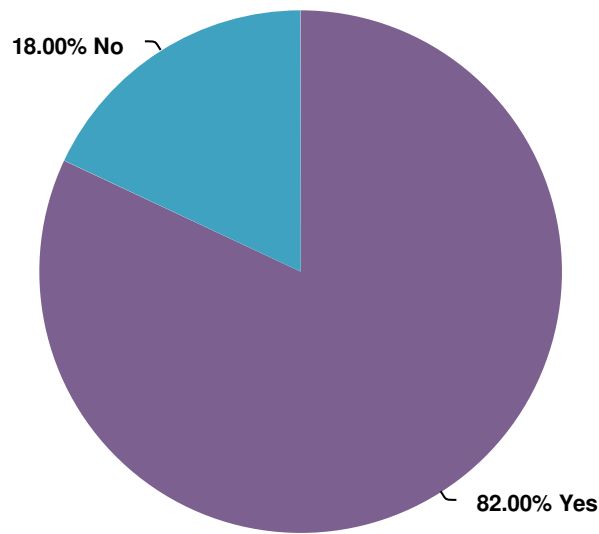

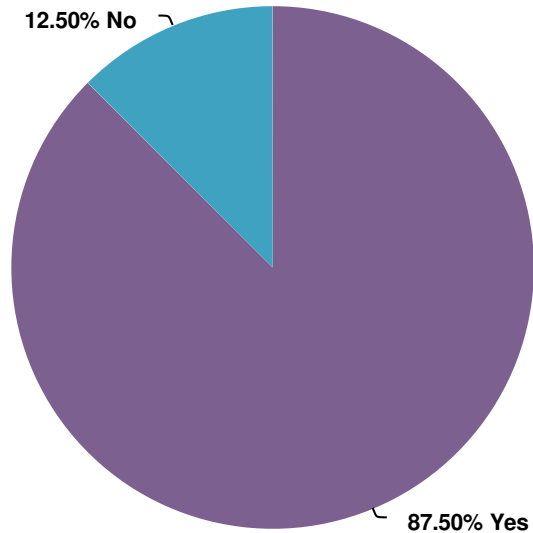

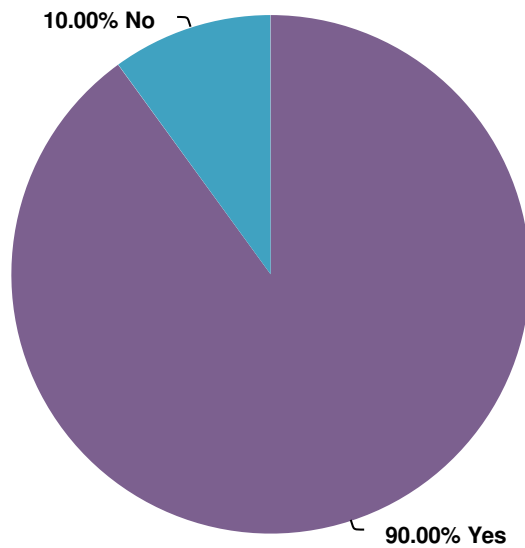

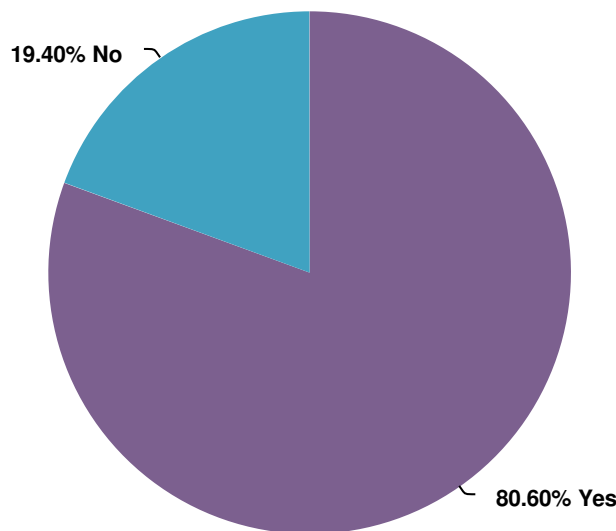

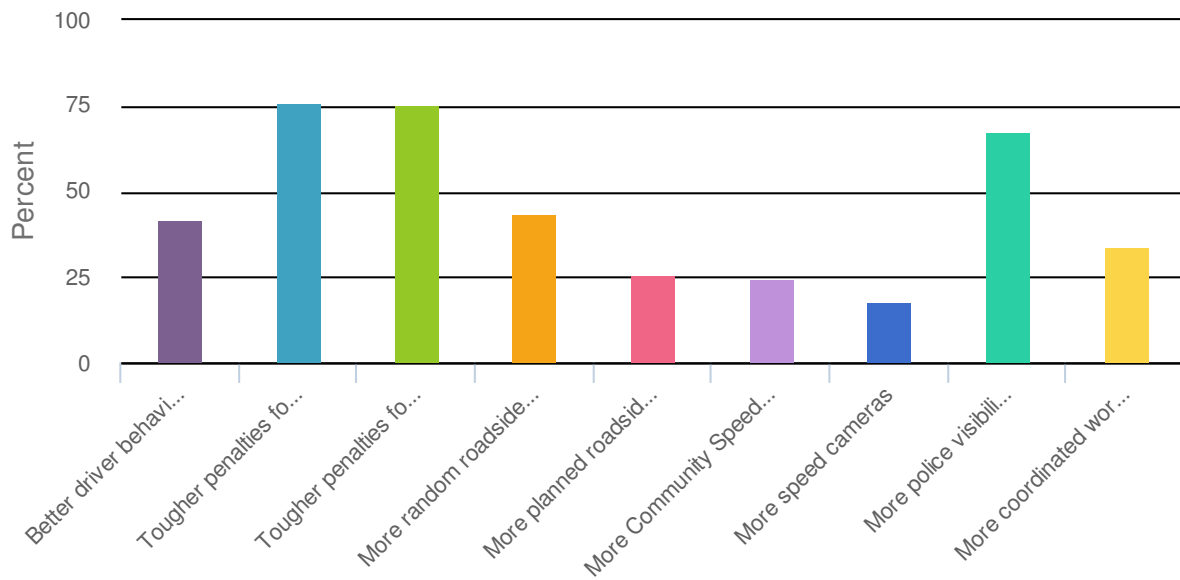

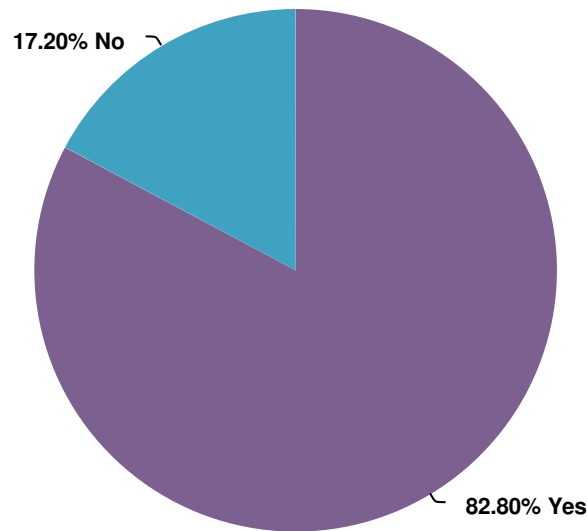

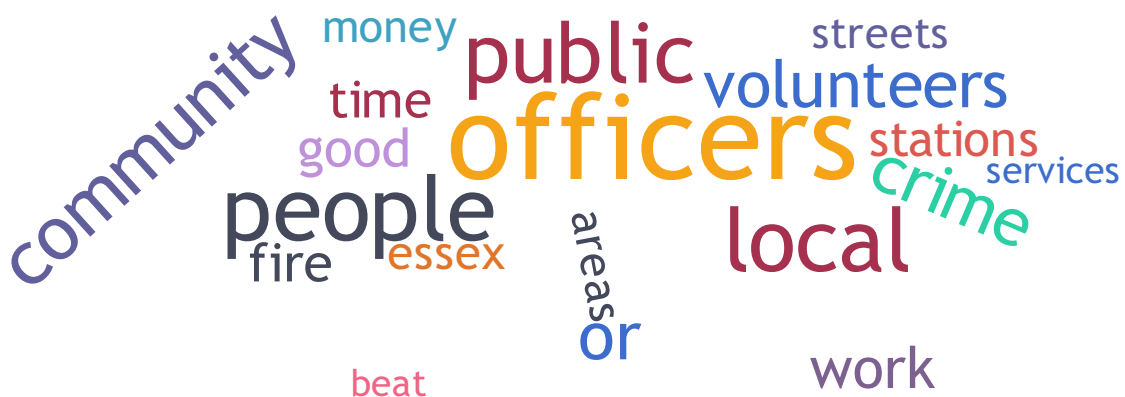

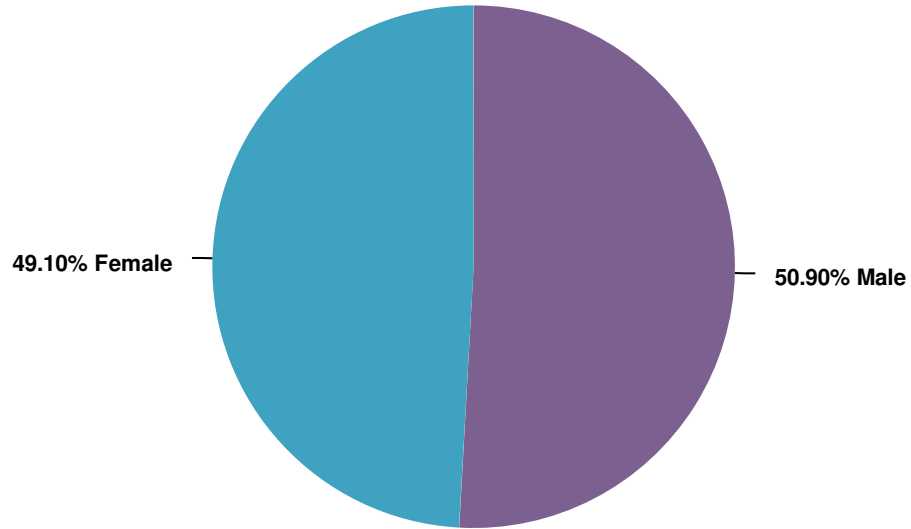

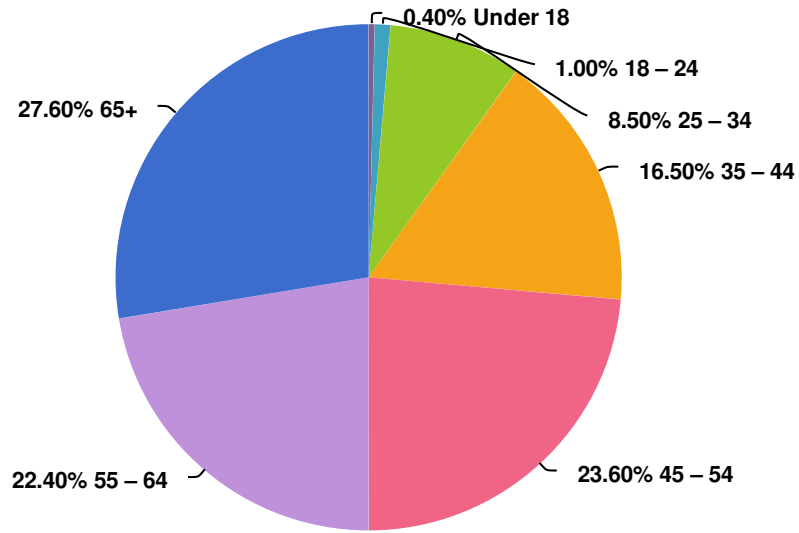

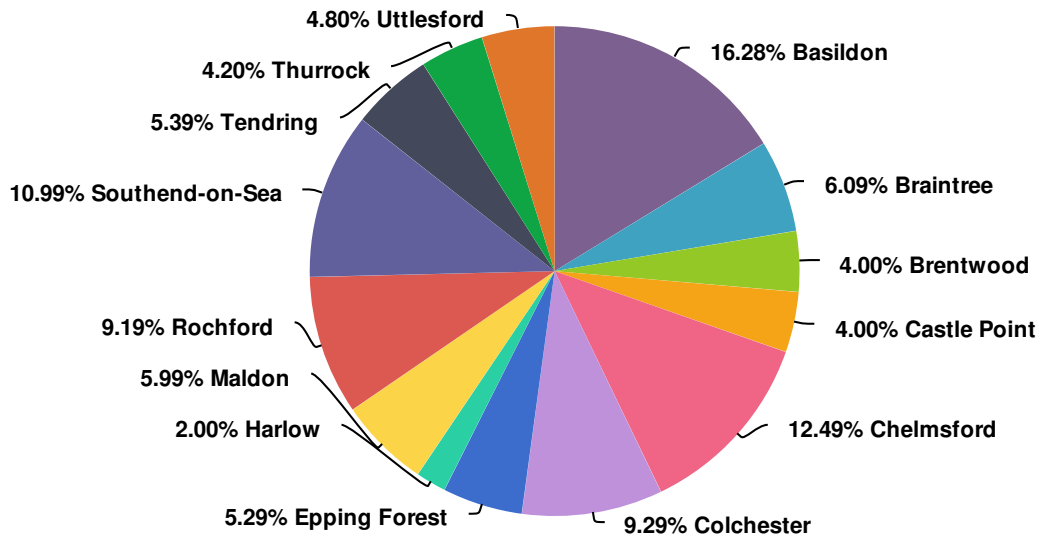
