1. Purpose of report

- 1.1. To seek approval for the allocation of £5,497.22 in the form of a crime and disorder reduction grant from the Victims Fund to Essex Community Rehabilitation Company (CRC).

2. Recommendations

- 2.1. Approve the allocation of a Victims Fund grant of £5,497.22 to the Essex CRC to cover the costs for Susan Kelly's interim Joint Domestic Abuse Triage Team (JDATT) operations manager's role for 3 months from January to March 2015.

3. Benefits of Proposal

- 3.1 The JDATT manager is a partnership role working to implement a hub model to ensure a joined-up, partnership approach to supporting victims of domestic abuse in Essex.

4. Background and proposal

- 4.1 Essex CRC provided the funding for the interim JDATT operations manager (Susan Kelly's) role until December '14. It was agreed that the OPCC and Essex County Council would jointly pick-up the costs for the final quarter of this financial year (Jan – March '15), until such a time as we have a clearer picture of the full resourcing model for JDATT / MARAC, and who is paying for what.

4.2 Essex County Council and the OPCC will each provide £5,497.22 funding towards this role for 3 months.

- Reducing domestic abuse
- Ensuring local solutions meet local problems

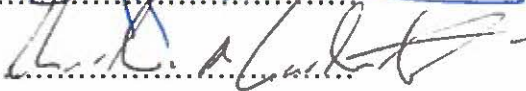
