## 1. Purpose of report

1.1. To seek approval for the allocation of £455 in the form of a crime and disorder reduction grant from the Hidden Harm Fund to Chelmsford City Council, whose activities will contribute to the priorities set out in the Police and Crime Plan for Essex.

#### 2. Recommendations

2.1. Approve the allocation of the Hidden Harm Fund grant to Chelmsford City Council to provide a suitable location for CSE training aimed at supporting taxi drivers to identify and report possible child sexual exploitation.

### 3. Benefits of Proposal

- 3.1 The project aims to:
  - \* raise awareness of issues regarding the safeguarding of children and adults
  - \* raise awareness of CSE, including definitions, risks and indicators
  - \* help taxi drivers to understand their responsibilities for taking action
  - \* help drivers understand reporting mechanisms
  - \* help drivers understand Essex Police's policies regarding CSE
  - \* ensure taxi drivers are able to respond appropriately when they suspect abuse
- 3.2 This funding will contribute towards the hire of a suitable venue (Hylands House, Chelmsford) to ensure attendance at the event is maximised
