1. Purpose of report

1.1. To seek approval for the allocation of £15,132 in the form of a crime and disorder reduction grant from the CSDF to Southend-on-Sea Domestic Abuse Projects (SoSDAP), whose activities will contribute to the priorities set out in the Police and Crime Plan for Essex.

2. Recommendations

2.1. Approve the allocation of the CSDF grant to SoSDAP to provide a BME support worker to engage hard-to-reach members of the community in Southend.

3. Benefits of Proposal

- 3.1. The project will improve provision of specialist DA support to victims from BME communities that are traditionally harder to engage. The support worker will provide direct support where necessary but will also improve awareness and promote an integrated service across the area.
- 3.2. The need for this project has been identified through SoSDAP's delivery of local domestic abuse services, which has experienced an increase in referrals from BME communities, with individuals having additional needs. These needs include immigration, financial control, languages, cultural and faith issues and access to employment / education.

4. Background and proposal

4.1. The project benefits from match-funded of £2,000 from SoSDAP and an investment of volunteer time.
