1. Purpose of report

- 1.1. To seek approval for a further allocation of £509.14 the form of a crime and disorder reduction grant from the CSDF to Essex Community Development CIC, whose activities will contribute to the priorities set out in the Police and Crime Plan for Essex.

2. Recommendations

- 2.1. Approve the allocation of the CSDF grant to support the Essex Community Development CIC Pitsea Youth Day.

3. Benefits of Proposal

3.1 The project's main aims are;

- To unite young people and local residents, and help them take ownership of their neighbourhoods
- Encourage young people to speak out and be able to report suspicious behaviour without fear
- Encourage young people to engage in meaningful activities
- Help people understand the roles and responsibilities of those in authority, why they exist, how they can be contacted and how they are able to help

4. Background and proposal

- 4.1 Pitsea Youth Day will take place on the 28th November. Young people have been invited to talk to the police, neighbourhood police, councillors and the MP regarding issues that have been raised as key concerns through a recent survey and documentary filmed in Pitsea.
- 4.2 The day will try to encourage young people to become neighbourhood champions where appropriate. Neighbourhood champions will be trained to and work to encourage young people to stay away from behaviour traits that promote crime and gangs.

5. Police and Crime Plan

Supports priorities in the Police and Crime Plan as follows;

- Reducing youth offending and youth re-offending
- Improving crime prevention
- Ensuring local solutions meet local problems
- Increasing efficiency in policing through collaborative working and innovation
- Reduce hidden harm




