Title of report PCC CSDF – Te	endring District Council, Domestic Homicide Reviews

1. Purpose of report

1.1. To seek approval for an allocation of £5000 in the form of a crime and disorder reduction grant from the CSDF to Tendring District Council whose activities will contribute to the priorities set out in the Police and Crime Plan for Essex.

2. Recommendations

2.1. Approve the allocation of the CSDF grant to Tendring District Council to part fund the cost of undertaking domestic homicide reviews (DHR).

3. Benefits of Proposal

- 3.1 The project's main aims are to;
 - Establish what lessons are to be learned from the domestic homicide regarding the way in which local professionals and organisations work individually and together to safeguard victims
 - identify clearly what those lessons are both within and between agencies, how and within what timescales that they will be acted on, and what is expected to change as a result;
 - apply these lessons to service responses for all domestic abuse victims and their children through intra and inter-agency working

4. Background and proposal

- 4.1 DHR's were established on a statutory basis under section 9 of the Domestic Violence, Crime and Victims Act (2004).
- 4.2 Tendring Community Safety Partnership (CSP) has initiated 3 DHRs since the start of 2015 which the CSP has funded in the main. In early 2016 Tendring CSP were notified that they have a further 2 DHRs to undertake, the process for which will commence in February/March 2016.
- 4.3 Tendring CSP has already funded £5000 of costs from their core CSP budget and have diverted a further £5000 of funds away from a project they were going to fund to ensure that existing DHRs can be funded. The funding requested from the PCC will enable Tendring CSP to fulfil their financial commitments for all DHRs for this financial year.

5. Police and Crime Plan

Supports priorities in the Police and Crime Plan as follows;

- Reducing hidden harm
- supporting victims of crime
- improving crime prevention
