# 1. Purpose of report

1.1. To seek approval for the allocation of £800 in the form of a crime and disorder reduction grant from the Community Safety Fund to Essex Police. These activities will contribute to the priorities set out in the Police and Crime Plan for Essex. WLDF are seeking this amount as a means of guaranteeing the guest speakers.

#### 2. Recommendations

2.1. Approve the allocation of the CSF grant to Essex Police to support the delivery of a Health and Wellbeing day organised by the Women's Leadership & Development Forum.

#### 3. Benefits of Proposal

- 3.1 Essex Police Women's Leadership Development Forum (WLDF) is planning another cooperate event to take place on Friday 21st October 2016. The event is focused on improving health and wellbeing of participants.
- 3.2 The event will focus on a number of important areas all of which have specialist guest speakers. As with previous events this event will support Essex Police officers & staff can identify ways in which to translate wellness insights into their daily lives both within and out of the workplace.
- 3.3 This funding will be used for;
  - £500 to discuss menopause in the work place by Kathryn Colas from Simply Hormones

- £400 £1000 for Yoga for stress relief at a Mindfulness summit
- £250 plus expenses/ NHS consultant for a Self-Harm charity from Nottingham to discuss self-harm signs and symptoms and managing
- Speakers to discuss mental health in the professional and personal arenas
- 3.4 WLDF will use the event to raise money for the Essex based charity PARC which provide play and recreational facilities for children with additional needs, and offers rest bite care for families and carers.

#### 4. Background and proposal

- 4.1 The event is being part-funded by Essex Police
- 4.2 WLDF have offered to provide OPCC with the opportunity to be represented on all promotional material, internal media campaigns and leaflets, in addition a stall can be provided to display material. By allocating funds OPCC will be recognised by guests attending the event as having a serious commitment to supporting officers and staff within Essex Police.
