1. Purpose of report

- 1.1. To seek approval for the allocation of £20,000 in the form of a crime and disorder reduction grant from the CSF to support the establishment of the Colchester Community Safety Hub.

2. Recommendations

- 2.1. Approve the allocation of the CSF grant to Essex Police to fund the establishment of a co-located Community Safety Hub in Colchester Police station.

3. Benefits of Proposal

- 3.1. This funding will provide necessary infrastructure and refurbishment works to accommodate the implementation of a local Community Safety Hub in Colchester police station.
- 3.2. This grant will enable partners from Colchester Borough Council and Essex Police to work collaboratively and share information and intelligence to produce better community safety outcomes. This arrangement will incorporate volunteer police cadets and Colchester Homeguard volunteers. The proposal allows additional partners including ECFRS, Health and the Royal Military Police (RMP) to work from the Police Station Hub on a hot desk basis

4. Background and proposal

- 4.1. In 2016 the PCC made a £120,000 fund available to CSPs across Essex to support the implementation of Community Safety Hubs in every Police district in the county.
- 4.2. This project benefits from match-funding from Colchester CSP and Essex Police.

5. Police and Crime Plan

- 5.1. Supports priorities in the Police and Crime Plan as follows;
 - Improving crime prevention
 - Reducing youth offending and youth re-offending
 - Ensuring local solutions meet local problems

6. Police Operational Implications

- 6.1. Essex Police will co-locate with multi-agency partners in Colchester Police Station

7. Financial Implications

- 7.1. The PCC would fund a £20,000 contribution to Essex Police

8. Legal Implications

- 8.1. The award of the grant is subject to the PCC's standard funding agreement




