1. Purpose of report

- 1.1. To seek approval for the allocation of £30,000 in the form of a crime and disorder reduction grant from the Community Safety Fund to Chelsea FC Foundation whose activities will contribute to the priorities set out in the Police and Crime Plan for Essex.

2. Recommendations

- 2.1. Approve the allocation of the CSF grant to Chelsea FC Foundation to support the extension of the current 'Breaking the Cycle' project.

3. Benefits of Proposal

- 3.1. This project works with partners including Barnardo's, Only Cowards Carry, Chelmsford Prison, and Essex County Council to reduce re-offending. The project works in the prison, coaching inmates to get them skills to use upon release, reducing the likelihood of reoffending. It also (via Barnardo's) supports young people affected by parental imprisonment to break the intergenerational cycle of offending.
- 3.2. The project runs on a collaborative approach that will continue to work closely with its existing partners to provide a 'whole family approach' to support the reduction of intergenerational offending and re-offending behaviour.



4. Background and proposal

- 4.1. The project is match-funded by the Premier League to the value of £40,000 per annum.


- 4.2. The project includes the delivery of 150 school sessions which will centre upon supporting 4 key outcomes;
1. Improved confidence
 2. More people with improved skills
 3. Stronger families
 4. Less offending behaviour
- 4.3. Last year's funding resulted in 65 offenders being accredited with one or more qualifications. 300 school sessions were delivered (across 10 schools) and the Barnardo's provided support 128 young people affected by parental imprisonment. 54% of those pupils from alternative education sessions (which engaged with 94 users) showed improved behaviour. 36% showed improved family relations. 57% showed increased confidence.

 - Tackling the consequences of alcohol and drugs abuse and mental health issues
