### 1. Purpose of report

1.1 To seek approval for the allocation of £2,500 in the form of a crime and disorder reduction grant from the 2017-18 Community Safety Fund to Brake

#### 2. Recommendations

2.1. Approve payment to the road safety charity Brake as a contribution to their national helpline and victim support packs, to support delivery of the Police and Crime Plan for Essex.

#### 3. Benefits of Proposal

3.1. Brake is a national charity that provides specialist support for bereaved and seriously injured road crime victims in partnership with police. Victim support packs are given to bereaved families by police promptly following every road death, in line with police protocols. Brake provides advice on criminal justice procedures, practical matters, and emotional support and comfort.

3.2. The national helpline uses trained professionals to provide needs-orientated support, signposting, information and advocacy on emotional, practical, domestic and procedural matters, often supporting victims through criminal justice procedures, and liaising with police and other officials on families' behalf.

4.1. Brake's support packs and helpline are part-funded by the Ministry of Justice and other PCC offices across the country.
