1. Purpose of report

To seek approval for an allocation of £101,428 in the form of crime and disorder reduction grants from the Community Safety Development Fund to the organisations listed in Section 2 below.

2. Recommendations

Approve the allocation of the CSDF grants to local organisations to deliver a variety of community safety projects that will support the objectives of the Police and Crime Plan.

3. Benefits of Proposal

The twelve projects that successfully applied for funding in round one of the 2017-2018 Community Safety Development Fund are;

Basildon SOS bus	£10,000	Funding to support the continuation of the Basildon SOS bus to support vulnerable people in the night time economy of Basildon festival leisure	
CSPs - Crimestoppers Cuckooing	£5,952	Campaign to raise awareness around cuckooing with professionals and the community – particularly vulnerable.	
Megacentre - Active Christian Trust	£10,000	Active Christian Trust employs professional youth and family workers who run a range of activities and interventions to support local young people and families.

57 West	£10,000	To develop a Southend Against Modern Slavery Partnership. Springfield youth group	£5,691	The Springfield Youth Group will work with young people aged 11-18 and will run on a Friday evening for 3 hours. The youth group will allow young people to come to a safe environment to be with their friends. As well as the physical activities, there will also be talks on specific topics for example; gang culture, knife crime and illicit substances.	
Colchester & Tendring Women's Refuge	£548	We have been selected by the SET Domestic Abuse Board (DAB) to be the central point of contact for their campaign about domestic abuse (DA) and its impact on older people. This is planned for December/January 2017.	
Gateway Community	£6,200	Funding for a part time youth worker for Saturday morning radio club	

Essex Boys and Girls Club	£10,000	Respect is an early intervention, alternative education programme identifying, through our successful partnership with schools, those students in school year 9 who are struggling with behaviour or respect in school and so becoming disengaged and more likely to fall into crime or to become victims of crime. Through a programme of challenging outdoor adventures, eight weeks life-skills sessions and a week-long residential either in Cumbria or Wales the young people will be offered an out of classroom experience to be helped to increase their self-confidence and self-esteem, understand actions and consequences and helped to appreciate the value of education.
