1. Purpose of report

To seek approval for an allocation of £12,500 in the form of crime and disorder reduction grants from the Community Safety Development Fund to Colchester United whose activities will contribute to the priorities set out in the Police and Crime Plan for Essex.

2. Recommendations

Approve the allocation of the CSDF grants to support Colchester United engage young people using football sessions to deliver to deliver a community programme that will support the objectives of the Police and Crime Plan.

3. Benefits of Proposal

The Colchester United community programme will help and support the reduction of crime and anti-social behaviour by providing activities to act as diversions and interventions to those young people of Colchester who may have the potential to commit crime.

4. Background and proposal

Colchester United mission statement is 'To enrich the lives of the people within the communities we operate through physical activity.'

The proposal is to enable Colchester United to expand the Kicks project. The Kicks project is a 10 week programme that engages young people in football sessions. As well as the football sessions, the sessions will include enrichment activity which will be supported by local partners to tackle the issues that lead to anti-social behaviour.

The programme has been running in Colchester for a year and has been successful in engaging young people from the community diverting them away from anti-social behaviour and providing support to engage young people back into education, training and employment. The Community Safety Partnership evaluated the outcome of the programme and agreed that it made a positive impact to the young people of Colchester.

5. Police and Crime Plan

This proposal supports the follow priority in the Police and Crime Plan as follows

- Crack down on Anti-Social Behaviour – Tackle anti-social behaviour to prevent longer term more serious crime


