**1. Purpose of report**

- 1.1. To seek approval for the allocation of £500 in the form of a discretionary grant from the OPCC's Community Safety Fund to Essex Police Memorial Trust

**2. Recommendations**

- 2.1. Approve the allocation of a grant to the Essex Police Memorial Trust to look after memorials to officers murdered and those who have died violently on duty, preserving graves and memorials, and helping the bereaved.

**3. Benefits of Proposal**

- 3.1. Support and assistance given to the bereaved families of officers murdered, or who die violently whilst on duty.
- 3.2. In the last year the Trust has restored several war memorials in Southend and purchased new memorials featuring Special Constabulary war deaths during World War I which are displayed in the foyer at Essex Police Headquarters.

**4. Background and proposal**

- 4.1. This is an annual award to the Charitable Trust, previously paid by the Police Authority, for the upkeep of graves and memorials.
- 4.2. The PFCC has made this grant available for the last few years, most recently in decision 0045/17.

**5. Police and Crime Plan**

- 5.1. This proposal supports priority 1 of the Police and Crime Plan, to provide more local, visible and accessible policing.

**6. Police Operational Implications**

**7. Financial Implications**

- 7.1. The PFCC will fund a one-off payment of £500 to the Essex Police Memorial Trust from the 2018-19 Community Safety Fund.
