# 1. Purpose of report

To seek approval for the allocation of £25,000 from the 2018-19 Community Safety Fund to Only Cowards Carry.

#### 2. Recommendations

Approve the allocation of an £25,000 from the PFCC's 2018-19 CSF to Only Cowards Carry to support the organisation in preventing and raising awareness of Knife Crime in Essex.

#### 3. Benefits of Proposal

Only Cowards Carry Weapons Awareness have 19 amnesty bins across North Essex Districts. The campaign has collected over 19000 potential weapons so far with the amnesty bin initiative.

They have educated over 40,000 young people on the dangers of carrying weapons across Essex.

Only Cowards Carry Weapons Awareness have a strong public media presence and are able to have a wide reach in promoting weapon awareness and preventing further harm from weapons in Essex

#### 4. Background and proposal

Only Cowards Carry Weapons awareness are a registered charity formed in 2012. It was established by local community members in response to the fatal stabbing of Jay Whiston in September 2012. The aims of the charity is to educate and raise awareness of the dangers and consequences of knives and weapons as well as other subjects including gang culture, drugs and alcohol misuse and bullying that can lead to the development of violent crime,

particularly amongst young people for the benefit of wider communities and public safety.

The charity has successfully launched a Knife Amnesty Campaign that has seen Amnesty Bins placed around Essex. There are knife amnesty bins placed in 19 different areas of the North Essex Districts.

The charity also has many volunteers that support the delivery of educating young people in Essex by attending school assemblies and attending community events.

Caroline Shearer the CEO has also completed a lot of work publicly often appearing on mainstream media channels to promote weapon awareness and prevent further harm.

The proposal is to provide funding to Only Cowards Carry to be allocated towards

- the Chief Executive to continue to grow and build partnerships across Essex raising awareness on weapons in Essex and identify funding opportunities
- a Project Manager who will be supporting the management of the amnesty bins, the management of education and develop applications for further funding opportunities.

#### 5. Police and Crime Plan

This project will support the PFCC's priority to protect reverse the trend in serious violence particularly delivering education and community programmes to help prevent knife crime.

#### 6. Police Operational Implications

No direct operational implications however the use of the amnesty bins is also used by Essex Police in disposing of weapons in Essex.

#### 7. Financial Implications

The PFCC will allocate a one-off grant payment of £25,000 from the 2018-19 Community Safety Fund to Essex Community Foundation.

# 8. Legal Implications

The grant is subject to the PFCC's Standard funding agreement.

Performance will be measured by the office of PFCC tracking progress against the grant.
