1. Purpose of report

To seek approval for the allocation of £500 to Tendring District Council. This will support Tendring District Council's activities in support of their Tornado 150 event at Walton-on-the-Naze station.

2. Recommendations

Approve the allocation of a one of payment for £500 from the 2017-18 Community Safety Fund to Tendring District Council

3. Benefits of Proposal

The event is expected to bring around 4,000 visitors to Walton and all proceeds will be going to St Helena Hospice in Clacton. The event will support the community and local businesses.

British Transport Police will ensure the security and the safety of visitors in and around Walton train station. Their presence should also act as a preventative measure to crime in the area.

4. Background and proposal

Walton-on-the-Naze celebrates 150 years of rail and is hosting a day of events across the town to honour the special anniversary. On Saturday 12th August multiple celebrations will take place across the town including the arrival of the Tornado steam train from London.

Once arriving in Walton train station the train will then run to and from Colchester five times giving 1500 visitors an opportunity to enjoy an historic trip. Proceeds from the day are being donated to St Helena Hospice in Clacton.

In order to provide a suitable visible police presence at this event, Tendring DC has arranged for two British transport police officers to be positioned at Walton-on-the-Naze train station. The British Transport Police will provide police presence and ensure the safety and security of members of the public.

The event will help to foster relationships with local communities and help the local economy to thrive which is in line with Priority 1 of the Police and Crime plan to have more local, visible and accessible policing.
