1. Purpose of the report

- 1.1. To approve the allocation of £399,000 from the PFCC's 2019-20 Violence & Vulnerability Fund to the organisations detailed in section 4.1 below for delivery against the objectives set out in the Essex Violence and Vulnerability Work Programme.

2. Recommendations

- 2.1. Approve the allocation of £399,000 to support partner organisations to deliver against the priorities within the Essex Violence and Vulnerability Work Programme.

3. Benefits of the proposal

- 3.1. This funding will enable local partners across Essex to have a positive impact on issues relating to violence and vulnerability, including gangs, 'county lines' and child criminal exploitation.
- 3.2. This funding supports organisations to deliver on their areas of work outlined in the Essex Violence and Vulnerability Framework (2018), to reduce serious violence and safeguard those being exploited and at risk of exploitation through gangs and 'county lines'.

3.3. The funding allocations have been developed and agreed by the PFCC and key strategic partners through the Violence and Vulnerability Strategic Executive Group, and Operations Board.

4.1. The PFCC will provide the following funding allocations:

The 2019-20 joint V&V budget consists of £350,000 Early Intervention Youth Funding (EIYF) from the Home Office, a contribution from Essex County Council of £500,000 and £200,000 from the Police, Fire and Crime Commissioner.

This is funding that the PFCC has received from the Home Office as part of a successful bid to the Early Intervention Youth Fund (EIYF), and with contributions from Essex County Council of £500,000 and from the Police, Fire and Crime Commissioner. This is the first tranche of funding from this combined 'Violence and Vulnerability Joint Budget'.
