
Executive Summary

- Three of the seven PFCC Priorities for Essex Police have been given a recommended grade of 'Good'. Recommended grades have been determined with reference to comparisons with Essex Police's Most Similar Group (MSG) of forces, internal Key Performance Indicators (KPIs), and professional judgement.
- Four of the seven PFCC priorities 1 (More local, visible and accessible policing), 3 (Breaking the cycle of domestic abuse), 4 (Reverse the trend in serious violence) and 6 (Protecting children & vulnerable people) have been given a recommended grade of 'Requires Improvement'. None of these recommended grades have changed since the July 2019 report.
- All Crime has risen by 8.6% for the 12 months to February 2020 compared to the 12 months to February 2019. The increase in offences can, in part, be attributed to changes to Home Office Counting Rules in relation to Stalking & Harassment, as well as better Crime Data Accuracy (CDA).
- Essex Police solved 159 fewer crimes in the 12 months to February 2020 compared to the 12 months to February 2019; this equates to a 0.7% decrease. The All Crime solved rate also continues to decline due to the increase in the number of crimes reported. The solved rate is currently 13.4%.
- Confidence (Essex Police internal survey) is at 65.2% (results to the 12 months to September 2019). Compared to year ending September 2018, confidence in the local police has significantly decreased (deterioration of 2.8% points). Confidence in the local police from the Crime Survey of England and Wales (CSEW) places Essex eighth in its MSG, and 10.7% points below the MSG average.
- Robbery of Business Property experienced a statistically significant decrease for the month of February 2020. This offence type also experienced a 31.8% decrease (62 fewer offences) for the 12 months to February 2020 compared to the 12 months to February 2019.
- Vehicle Interference experienced a statistically significant increase for the month of February 2020. This offence type experienced a 9.0% increase in offences (186 more). Essex Police solved 46 more of these offences (a 191.7% increase) for the 12 months to February 2020 compared to the 12 months to February 2019.

Essex experienced an 8.6% increase in All Crime (13,463 additional offences) for the 12 months to February 2020 compared to the 12 months to February 2019. Essex is eighth in its Most Similar Group of forces (MSG) for crime per 1,000 population.

The increase in offences can, in part, be attributed to changes to Home Office Counting Rules in relation to Stalking & Harassment, as well as better Crime Data Accuracy (CDA).

Essex was graded as Outstanding in its recent HMICFRS Crime Data Integrity (CDI) inspection. Essex Police is only the third force of the 41 that have been judged as outstanding on the first visit in this inspection programme.



Confidence (Essex Police internal survey) is at 65.2% (results to the 12 months to September 2019). Compared to year ending September 2018, confidence in the local police has significantly decreased (deterioration of 2.8% points).

Confidence in the local police from the Crime Survey of England and Wales (CSEW) places Essex eighth in its MSG, and 10.7% points below the MSG average. However, the sample size from this survey is not representative at a sufficiently small scale to measure local issues. The Essex Police internal survey (results detailed above) was therefore introduced to achieve a more accurate local measure with a small margin of error. The results from the Essex Police survey show that the Force performs significantly better on confidence in local policing than the results from the CSEW, which asks the same question.

Due to the fact that Essex is 8th in its MSG for both crime per 1,000 population and for confidence in local police (CSEW), and that the Essex Police internal survey shows a deterioration in confidence in local police, a grade of Requires Improvement is recommended.

Essex experienced an 11.3% reduction (5,279 fewer) in Anti-Social Behaviour (ASB) incidents for the 12 months to February 2020 compared to the 12 months to February 2019. Part of this decrease is due to better Crime Data Accuracy (CDA); more incidents reported as ASB are now being correctly recorded as crimes. Some of the decrease may also be due to people reporting incidents directly to the Council and Housing Authorities.


ASB Perception (from the Crime Survey of England and Wales) in Essex experienced a 3.0% point decrease (improvement). Essex is 1.1% points better than the MSG average; this places Essex second in its Most Similar Group of forces. However, results of Essex's internal survey significantly decreased in relation to how well Essex and the organisations they work with deal with ASB (deterioration of 3.9% points).

Due to the reduction in ASB incidents, and the fact that ASB Perception is better than the MSG average, a grade of Good is recommended.

Essex experienced a 3.3% increase (1,364 more) in Domestic Abuse incidents and a 10.6% increase (2,003 more) in repeat incidents of Domestic Abuse for the 12 months to February 2020 compared to the 12 months to February 2019. The increase in crime, in part, can be attributed to better Crime Data Accuracy (CDA), and changes to Home Office Counting Rules (HOCR) in relation to Stalking & Harassment.


The Domestic Abuse solved rate fell by 3.4% points to 9.9% during the same period. The number of offences solved has also fallen by 373 offences.

Due to the increase in repeat incidents and the decrease in both the solved volume and the solved rate, a grade of Requires Improvement is recommended.





Essex saw an increase of 43 Homicides (to 59 offences) for the 12 months to February 2020 compared to the 12 months to February 2019. This includes the tragic incident where 39 Vietnamese nationals were discovered in a lorry trailer in Grays. Essex is eighth in its Most Similar Group (MSG) of forces for offences per 1,000 population, and is higher than the MSG average.

There was a 5.4% increase (786 more offences) in Violence with Injury. Essex is fifth in its MSG for offences per 1,000 population, and is slightly worse than the MSG average. The increase in this offence is, in part, due to the rise in domestic abuse related Violence with Injury (12.5% increase, 610 more offences); 35.6% of Violence with Injury is domestic abuse-related.

Due to the fact that Essex continues to experience an increase in Violence with Injury, a grade of Requires Improvement is recommended.


26 Organised Crime Group (OCG) disruptions were conducted in Essex in January to February 2020 inclusive compared with 13 in the same months in 2019 (13 more).* In January 2019 there was a change in the way in which the number of OCG disruptions were counted; this follows National Crime Agency (NCA) and Eastern Region Special Operations Unit (ERSOU) guidance to ensure that all forces record disruptions in the same way. Year-on-year comparisons can only therefore be made from January 2020.


Trafficking of drug arrests, which are also as a result of police proactivity, increased by 34.0% (506 more) for the 12 months to February 2020 compared to the 12 months to February 2019. In the same period, 22.5% more trafficking of drugs offences have been recorded (173 more offences to 942).

Due to the increase in Trafficking of Drug Arrests, a grade of Good is recommended.

*Please note that the number of Organised Crime Group disruptions are a comparison of January and February 2019 and January and February 2020, as there was a change in the method by which these disruptions were counted from January 2019.




There was a 47.1% increase (97 more) in the number of solved Child Abuse Outcomes in the 12 months to February 2020 compared to the 12 months to February 2019.

57.2% more offences (an additional 2,035) were recorded in the 12 months to February 2020 compared to the 12 months to February 2019. There was a 0.4% point decrease in the solved rate (from 5.8% to 5.4%).

In spite of the increase in the number of Child Abuse solved outcomes, there is still a reduction in the solved rate. A grade of Requires Improvement is therefore recommended.

There was a 0.8% decrease (7 fewer) in the numbers of those Killed or Seriously Injured (KSI) in Essex for the 12 months to February 2020 compared to the 12 months to February 2019. Please note most KSIs do not result in a criminal offence of death or serious injury caused by dangerous driving and are recorded as road traffic incidents. Essex is placed sixth in its Most Similar Group (MSG) of forces for casualties per 100 million vehicle kilometres (results to December 2018).

There has been a 38.1% decrease in mobile phone crime (1,019 fewer offences) and a 27.5% increase (802 more offences) in drink/drug driving with drug driving seeing a 51.8% increase (624 more).

Due to the decrease in KSIs, a grade of Good is recommended. As of December 2018, Essex was slightly worse than the MSG average per 100 million km. However, due to the fact that more recent national figures have not been released, the current position cannot be updated. The date of the next national release has not yet been confirmed.

Monthly Performance Overview: Exceptions

Exceptions Overview

The following offence types experienced statistically significant changes for the month of February 2020:

- Robbery of Business Property decrease
- Vehicle Interference increase

Robbery of Business Property

31.8% decrease (62 fewer offences) for the 12 months to February 2020 compared to the 12 months to February 2019. The Force saw a statistically exceptional decrease in the month of February 2020 recording the lowest number of crimes (three) since August 2015.

Vehicle Interference - Offences

9.0% increase (186 more offences) for the 12 months to February 2020 compared to the 12 months to February 2019. There were statistically exceptionally increases in three Districts in February 2020.

Vehicle Interference – Solved Rate

46 more solved offences (a 191.7% increase) for the 12 months to February 2020 compared to the 12 months to February 2019. The Force saw a statistically exceptional increase in the month of February 2020. Two individual suspects, and two suspects working together, were found guilty for ten of the fifteen solved crimes in February 2020.

Monthly Performance Overview: Of Note

Priority 1 – More local, visible and accessible policing

Single on-line Home - Firearms Licencing

Improved service for the public in relation to Firearms licensing. An interim non-payment version of Firearms licencing went live as part of the main September 2019 Go Live. On the 26th February 2020 this was replaced with the enhanced version which included both online application forms and online payment.

Priority 4 – Reverse the trend in serious violence

Operation Gloss

This pilot project will see a fast-tracked referral process from Border Force, notifying Essex Police directly when prohibited weapons are intercepted. The aim is to educate individuals about the law on ordering weapons online and the impact of carrying and using weapons and will hopefully be one of a number of opportunities used to intervene at an early stage to prevent and reduce serious violence.

<u>Priority 5 – Tackle gangs and organised crime</u>

Operation Produce

Operation Produce ran for two weeks in February in the North LPA (following a similar operation in the South LPA last month). This important work is part of Operation Sceptre, our ongoing work to tackle serious violence and knife crime in public places. Officers dedicated more than 3,500 extra hours on patrol resulting in 73 arrests and eight drugs lines were identified.

Operation Hemlock

Our officers were joined by the Metropolitan Police Service and British Transport Police as part of a joint operation on an investigation into the theft of vehicles, particularly high value cars, sharing intelligence and pooling resources with more than 450 officers involved. Warrants were carried out in Essex and London following months of collaborative work from several different organisations including the Government Agency Intelligence Network (GAIN). GAIN is made up of Government departments and law enforcement agencies which share intelligence and information to disrupt organised crime groups.

- ² The confidence interval is the range +/- between where the survey result may lie. This is mainly influenced by the number of people answering the survey. The more people that answer the survey, the smaller the interval range.
- ³ Crime Survey for England and Wales (CSEW): 12 months to September 2019 vs. 12 months to September 2018.
- ⁴ Question from Essex Police's own confidence and perception survey (Question 8a). Results are for the period 12 months to September 2019 versus the 12 months to September 2018.
- ⁵ Please note that the number of Organised Crime Group disruptions are a comparison of January and February 2019 and January and February 2020 only due to a change in counting rules that occurred in January 2019.
- From January 2019, activity has been recorded rather than the number of people arrested. If there was a day of action, for example, and five people were arrested, this would formerly have counted as five disruptions, but now will count as one. The change stems from confusion over the previous guidelines, with police forces counting disruptions in different ways.
- ⁶ Solved outcomes are crimes that result in: charge or summons, caution, crimes taken into consideration, fixed penalty notice, cannabis warning or community resolution.
- ⁷ 'Killed or Seriously Injured' (KSI) refers to all people killed or seriously injured on Essex's roads, regardless of whether any criminal offences were committed. Crime Severity Score (CSS) - Based on the ONS Crime Severity Score which replaces the Combridge Harm Index - data are for the financial year 2018/19, (a total of 21 crime types have been ranked where scores are available).

The CSS excludes proactively generated crime detection by police i.e. State Based Crime, as these offences do not reliably measure harms experienced by the population. Rather, they measure the resources invested in catching offenders.

Yr on Yr 1m %/% pt. diff. - compares the month of February 2020 with the month of February 2019.

Yr on Yr 3m %/% pt. diff. - compares the three months to February 2020 with the three months to February 2019.

Z Score - Standard Score over 1.96 or under -1.96. Standard Scores are used to calculate the probability of an event occurring within a normal distribution; they are also used to compare two scores from different normal distributions (for example the number of offences per police District). In this document, Standard Scores are calculated in the following way: (current month's figure, minus the average figure per month over the previous three years) divided by the Standard Deviation of the same three year period. Standard Deviation is a measure to determine how spread out figures are from the average or "mean" a large standard deviation indicates the data is widely spread; if small, the data will be more clustered together.
