#### **BACKGROUND**

This report provides an update on HMICFRS Cycle 2 planned activity and timetable. At the time of writing HMICFRS has been paused due to the Covid 19 pandemic and these plans may be subject to change when HMICFRS activity resumes.

#### Service Liaison Lead

Andy Smith has been appointed as Service Liaison Lead for Essex County Fire and Rescue Service during cycle 2. Andy has had an introductory visit to the Service and will plan in regular engagement visits throughout cycle 2 ahead of our next Inspection. The areas that Andy will focus his engagement visits on is as follows:-

- Control Room Visit
- Watch Visits (including on-call)
- Training Centre Visit
- Observe a Senior Management Team Meeting
- Meet leads for health and safety and operational assurance.
- Observe community safety activity, including safe and well visits
- Observe a Fire Authority Meeting
- Engagement with diversity and inclusion lead/team.
- Meet protection teams and observe protection activity
- Engagement with intelligence and analysis teams to understand how data is used
- Engagement meetings with all representative bodies within the service

#### **Protection Re-visit**

HMICFRS are planning to conduct a re-visit to the Service week commencing 10 August 2020 to evaluate progress the Service has made against delivery of its Protection Improvement Plan. The Team of HMICFRS Inspectors will be on site for 4 days. The visit will include the following activity:-

Interviews with CFO, PFCC, ACFO Protection
Document Review (e.g. Protection Strategy, RBIP etc)
Station visits to talk with Crews and TFS Teams
ICT (Replacement system for Protection)
HR (Workforce Planning, Recruitment, Succession Planning)
