PLACE	COVID Safe Work Place Risk Assessment PLACE	Health & Safety and Property	 The Health & Safety Team have completed all site specific risk assessments at all sites. Sites are now deemed COVID Safe. Site specific risk assessments have been saved onto Recovery Programme Teams Site. Publication of the COVID Safe site specific risk assessments have been added to the intranet for colleagues to view. As per government guidelines, work is underway to produce a Risk Assessment Summary which will be published externally for all visitors. The quarterly COVID Safe Work Place Risk Assessment are underway at all sites.
PLACE	Property Tasks	All	 COVID cleaning contractor implemented at all sites Head Quarters Remaining COVID safe measures at Service Headquarters implemented. These included; door signage, floor markings, meeting room capacity information and Perspex covering at reception and in the staff restaurant. Removal of non COVID safe equipment and personal items from all desks and muster area. Team locations agreed with department heads. COVID safe measures implemented within the staff restaurant. Staff Induction Pack drafted and issued to Recovery Leads & Health and Safety for review and comment ICT Kit Day – All ICT on site at KP on 28th September to install docking stations.
PEOPLE	Return to Work Assessment Toolkit	HR and Occupation Health	 Returning to workplace toolkit complete by all line managers. Further to the launch of the Return to Work Assessment Toolkit HR have cross referenced the Civica records of those who are recorded as 'Self-Isolating – High Risk' with the RTW forms that have been submitted to the HR Support Mailbox to identify any gaps. The People Partners have been notified of these gaps and have been contacting the line managers of these individuals to provide support. Total of 278 forms submitted to the HR Support Mailbox for filing on PRFs. These forms have been completed not just for those who have been shielding or need to have their working from home arrangements reviewed as part of phase 1, these form appear to have also been completed for those who fall within phase 2. Return to Workplace meetings in August and September with Service Area Lead/Department Head to discuss returning to the workplace (KP/SDP's) in order to understand desk capacity, staff numbers and working patterns. Individual discussions took place with specialised departments: ICT, OCAT, Health & Safety and Canteen

28 September

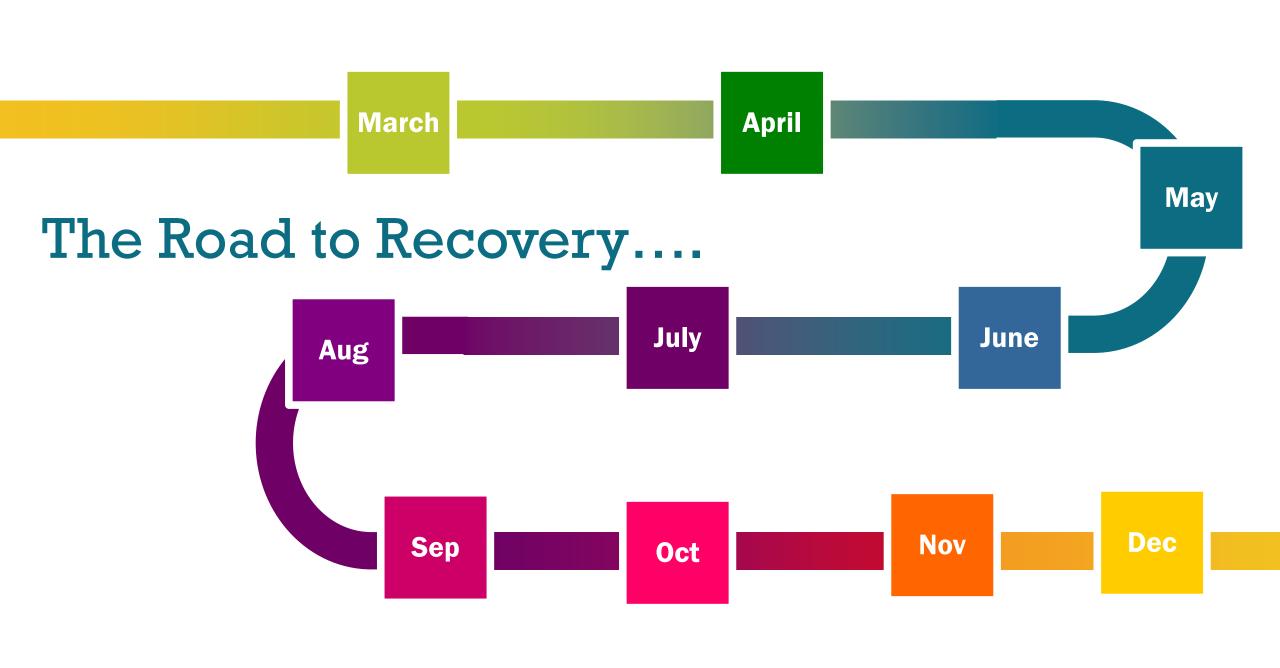
- ✓ Completion of Return to workplace inductions for all teams
