		When comparing year on year figures it is worth noting that the remit of the PFCC is significantly larger than the Police Authority. This includes the commissioning of services previously undertaken by the Ministry of Justice such as victim support and specialist support services. Since October 2017 the Commissioner has also undertaken governance of the Fire and Rescue Service in Essex. The cost of this service prior to joint governance was £400,000. Since joint governance the cost has reduced to £200,000 allowing the other £200,000 to be reinvested in the Service.  2.
