#### 1. Purpose of the report

1.1. To seek approval for the allocation of £32,117 in the form of a crime and disorder reduction grant to Changing Pathways to provide a Stalking Advocate.

#### 2. Recommendations

2.1. Approve the allocation of £32,117 to Changing Pathways for the salary of a Stalking Advocate who will support victims of stalking and harassment.

#### 3. Benefits of the proposal

- 3.1. A Stalking Advocate will provide emotional support and practical assistance, including help to access legal advice, assistance with safety planning, risk assessment, signposting/connection with other agencies, information on rights, legislation and entitlements for victims.
- 3.2. The role provides support for victims in order for them to cope and move on from the impact of the crime. This is evidenced by monitoring outcomes of victims. In 2019/20 victims of stalking who were supported by an independent advocate showed:

#### 4. Background and proposal

- 4.1. Changing Pathways are a charitable organisation who supports victims of domestic abuse.
- 4.2. Stalking is a form of domestic abuse. It is defined as a pattern of unwanted, fixated and obsessive behaviour which is intrusive and causes fear of violence or serious alarm or distress.
- 4.3. The restrictions of the COVID pandemic is expected to increase the risk of stalking and harassment. Published in a recent article<sup>1</sup> 'Deputy Chief Constable Paul Mills, stalking and harassment lead for the National Police Chiefs Council, said: "Nationally we have seen an increase in stalking offences since March and factors such as loss of employment, working from home or being furloughed has increased perpetrator's time and capacity to target victims.' In Essex stalking and harassment crime has seen an increase of 5% Nov 2019 23070, Nov 2020 24262.
- 4.4. Changing Pathways recognised the need to provide specialist support to victims of stalking and in 2016 Changing Pathways launched a stalking advocate role with the support of Big Lottery funding.
- 4.5. Changing Pathways have demonstrated that there is a need for this specialist support in Essex and victims of stalking and harassment require advocacy support that understands the impact that stalking has on their lives. In 2019/20 Changing Pathways Stalking Advocate supported 83 victims and on average each victim was supported by the service for six months.
- 4.6. The current funding is coming to an end and Changing Pathways are seeking support for this role to continue. It is proposed that the PFCC allocates £32,117 to continue to support the stalking advocacy role for one year from 1<sup>st</sup> April 2021 until 31<sup>st</sup> March 2022.

#### 5. Alternative options considered and rejected

5.1. The PFCC could opt not to support this project and Changing Pathways will have to continue to seek alternative funding opportunities. If the PFCC chose not to support this increases the risk that Changing Pathways will not be able to continue with this dedicated post.

6.1. This grant supports the PFCC priority to break the cycle of domestic abuse by supporting victims of stalking which is a form of domestic abuse.

- 11.3. Domestic Abuse is typically a gender-based crime towards females. The service does support male victims however, it is expected that the service will support a higher proportion of female victims.

#### 12. Risks

- 12.1. There is a risk that the new post does not meets its set objectives. The outcomes for this new role will be monitored through existing quarterly performance meetings.
