1. Purpose of the report

1.1. To endorse the signing of the Animal Welfare Independent Visitors Scheme for Dogs Memorandum of Understanding supporting the partnership arrangements between the Dogs Trust, PFCC and Essex Police Dog Section.

2. Recommendations

2.1. For the PFCC to sign the Animal Welfare Independent Visitors Scheme for Dogs Memorandum of Understanding (MoU).

3. Benefits of the proposal

3.1. Signing the MoU will enable the partnership work between the Dogs Trust, PFCC and Essex Police Dog unit to continue supporting the continuation of the Animal Welfare Independent Visitor's Scheme (AWS). The scheme provides independent checks on animal welfare and reassurance that animals in the care of Essex Police are being cared for appropriately.

4. Background and proposal

- 4.1. The training and welfare of dogs engaged in police work must be open and be seen to be open. The Animal Welfare Independent Visitors Scheme (AWS) was piloted by Lancashire Police and then rolled out across other forces.
- 4.2. In 2006 the Animal Welfare Act brought in an even greater responsibility for police forces to provide for the needs of the dogs in their care. The Dogs Trust has supported chief constables and Police, Fire and Crime Commissioners to set up

and run the Animal Welfare Independent Visitors Scheme for their force, through the provision of information, meetings and training for both police officers and Independent Visitors.

- 4.3. The Dogs Trust ensures that the scheme is running in accordance with the guidelines and awards those who are complying with the scheme with a certificate of compliance.
- 4.4. The Memorandum of Understanding outlines the expectations of each party regarding the AWS.

5. Alternative options considered and rejected

5.1. The PFCC has the option not to sign the MoU however this would be of detriment to Essex Police's involvement with the scheme and effectively result in the partnership not being able to continue.

6. Police and Crime Plan

6.1. This partnership supports the PFCC priority for more local, visible and accessible policing, improve the transparency of the force and supports the Essex Police Dogs Section to continue to carry out their important operational role.
