1. Purpose of the report

1.1. To approve the allocation of funding from the Restorative Justice budget for a volunteer appreciation event.

2. Recommendations

2.1. Approve the allocation of £2,000 from the 2020-21 RJ budget to fund an event to recognise and thank volunteers from all three of the volunteering roles in the Police, Fire and Crime Commissioner's Office.

3. Benefits of the proposal

3.1. This decision will allow the PFCC to formally recognise the volunteers for the work they have put in over the last 12 months. Events such as this ensure that volunteers feel valued and appreciated and may lower turnover of volunteers.

4. Background and proposal

- 4.1. The first of these appreciation events took place in 2019, and received very positive feedback from volunteers. 100% of those who attended said it was worthwhile and 95% responded positively when asked if the event should be repeated. One attendee said "I felt really appreciated, well done". This event was due to be held annually, however COVID restrictions meant that it did not go ahead last year.
- 4.2. Those who volunteer for the Police, Fire and Crime Commissioner have ensured that the roles have continued during the COVID pandemic and the RJ volunteers alone have logged 680 hours of work last year. They have demonstrated flexibility and determination to maintain a high standard and support the PFCC, as well as dedication to the role.
- 4.3. The event will be based on the structure of the 2019 event, taking the feedback from attendees as a starting point for improvements. As before, we plan to allow

the volunteers to network, listen to speakers, see the police dogs in action and receive awards for long service and exceptional contribution.

- 4.4. We intend to use the Essex Police Pavilion as a venue, as we can utilise the outdoor space to offset any COVID risk.
- 4.5. This event was originally planned for 26th June but had to be postponed due to COVID-19 restrictions. The new date held for this event is Saturday, September 18th 2021.

5. Police and Crime Plan

5.1. The Police and Crime Plan includes reference to volunteering being a building block for success. By recognising and rewarding those who choose to give their time, we are encouraging a long-standing volunteer relationship.

6. Police operational implications

6.1. Police officers and staff may be invited to attend the event and their attendance should be managed around other commitments and operational priorities.

7. Financial implications

7.1. The PFCC will fund £2,000 from the RJ element of the 2020-21 Victims Budget to support the event. All volunteers from across the 3 roles (Independent Custody Visitors, Dog Welfare Visitors and Restorative Justice Volunteers) will be invited, however as the majority of volunteers are attached to the RJ Team, this is the decided budget source.

9.1. Staff involved in all 3 schemes will be invited to attend the event, as well as the PFCC and Deputy PFCC. The event is due to take place on a Saturday so consideration must be made for staff to claim this time back.
