Stage 1 – Detail of policy, function, project or proposal

Briefly describe the aims, objectives and outcomes of the policy/function

The PFCC's has responsibility to commission services to support victims of crime. In order to deliver this the Ministry of Justice provides a Victims grant which is utilised by commissioning Domestic Abuse, Sexual Abuse, and all other crime support services.

MoJ announced additional funding of £40m for victims' services in order to ensure that services continue to be available in 2021-22 following the impact and increase demand of COVID. Of which, £4.625m for Sexual Violence and £8.95m for Domestic Abuse has been ringfenced and allocated to PCCs to distribute. The Ministry of Justice will allocate this to PCCs by providing an uplift to their existing annual 2021/22 Victims Grant. The increase in funding for Essex is

- Domestic Abuse £287,115
- Sexual Violence £139,778
- Rape Support Fund £147,709. Essex PFCC was also successful in obtaining additional funding for Independent Sexual Violence Advisors (ISVAs) and Independent Domestic Violence Advisors (IDVAs) for two years
- £500,820 for 2021/22
- £554,023 for 2022/23

What policies/procedures/functions are relevant to this area?

The PFCC's has responsibility to commission services to support victims of crime

Which individuals and organisations are likely to be affected by the policy/function and in what way?

Victim of crime are the focus of the funding and will benefit by additional support that will be provided.

Decision sheet 'MoJ additional victims funding – Assessment process' identified all organisations awarded funding. However, as part of the funding some organisations will be supporting individuals with the below protected characteristics

- Gender reassignment
- Age
- Sexual Orientation
- Sex
- Disability
- Race

What relevant quantitative data has been considered?

Evidence of future need was assessed which included volumes of victims supported, average caseloads and average wait times.

What relevant qualitative data has been considered?

The PFCC regularly engages services to conduct performance reviews therefore qualitative data was considered taken from performance reporting. In addition, organisations outlined the evidence of need within an application which was reviewed.

Has the function/policy been subject to consultation? If no, why not? If yes, which individuals and organisations were consulted and what form did consultation take?

The PFCC engaged with existing commissioned services to understand the current and future demand to ensure funding is used to support the victims already in services to avoid increased waiting times and to be able to support increased complex need.

The PFCC Senior Management Team were kept updated on the progress of funding and the funding approached was approved via a decision sheet 11-21.

Were any gaps in information identified? If so, what consideration has been given to commissioning work where required?

No gaps were identified at this stage. Monitoring arrangements will be put in place to monitor the impact of this funding. Within these monitoring arrangements demographic information will be provided. The PFCC will review the outputs from each project and will identify any gaps that may need to be addressed or considered in the future.
