#### Stage 1 – Detail of policy, function, project or proposal

#### Briefly describe the aims, objectives and outcomes of the policy/function

The Safer Streets Fund is a £20m fund, to design and deliver local crime prevention plans in hotspot areas with the outcome of reducing neighbourhood crimes through situational prevention. Essex PFCC was able to submit bids of up to £432,000, for three defined local areas within Essex that are persistently and disproportionately affected by neighbourhood crime.

Essex PFCC submitted three bids for Grays, Clacton, and Southend

The Home Office announced the outcome of the Safer Streets Fund on 3 June 2021. Essex PFCC was successful in receiving the total amount of funding £432,000 for the Grays application.

#### What policies/procedures/functions are relevant to this area?

Prevention is a building block of success within the Police and Crime Plan. Improving the wellbeing of people across Essex, making sure that crime and anti-social behaviour do not happen in the first place and that children and vulnerable people are kept safe from harm.

#### Stage 2 – Consider the Evidence

Which individuals and organisations are likely to be affected by the policy/function and in what way?

Members of the public within Grays will be positively affected by this project with additional lighting, CCTV, and positive engagement by Thurrock Council colleagues. There is also a small piece of work with Essex Fire who will be engaging vulnerable people in their homes to educate on crime prevention.

Due to the project seeking to prevent the public of Gray all protected characteristics could be affected

#### What relevant quantitative data has been considered?

In order to develop the application for Safer Streets Funding crime data was evaluated. This data did not break down the full demographic of the town as it was not relevant for the application however it did highlight that the vulnerable classification of groups within the area are students and professionals.

### What relevant qualitative data has been considered?

Throughout the process feedback was obtained from Thurrock Community safety Partnership. Similar to the quantitative data demographic information was not obtained as this was not relevant information required to develop the bid.

Has the function/policy been subject to consultation? If no, why not? If yes, which individuals and organisations were consulted and what form did consultation take?

In order to develop the application, the Community Safety Partnership and Essex Police was engaged and provided their endorsement. The CSP membership includes many local organisations that represent the local community.

Were any gaps in information identified? If so, what consideration has been given to commissioning work where required?

There are no gaps identified so far but it is important that the working group who has been formed to implement this project, monitors the impact on protected characteristics to ensure there is no adverse effect. For example

The engagement and enforcement officer should monitor who they are engaging with and what penalty notices are issued. This should be regularly reviewed to ensure it is proportionate

The Essex Fire service deliver the Safe and Well scheme. This is targeted to vulnerable individuals that request support. Demographic information should be captured to ensure that the service is providing support to all those that request it

The project plans to increase CCTV. CCTV in Thurrock has its own governance to ensure that meets all information security criteria and remains ethical. The working group should seek assurances that the new cameras are included within the Thurrock governance framework
