The Operational Assurance department produce post incident and exercise reports sharing organisational learning with the Service Leadership Team.

OPTIONS AND ANALYSIS

The Operational Assurance department gather operational performance data following incident and exercise debriefing and the station audit process. An Operational Assurance Group is set up to monitor and review performance data and information within the operational environment, through:

- station audits
- · operational assurance reports
- Incident and exercise debrief process outcomes
- thematic reviews

The Operational Assurance department produce a quarterly report for Board review.

RISKS AND MITIGATIONS

Ensuring that lessons are learned from previous incidents so that identical or similar accidents arising from work activities can be prevented in the future is central to the health and safety and welfare of the UK Fire and Rescue Service.

If learning from incidents can be carried out consistently and the lessons acted on effectively and shared more widely, the Service can continue to improve its operational performance and safety.
