- 3.2 A report was presented to Performance and Resources Scrutiny Board on 31st January with a draft timetable for the production of the 2021/22 Statement of Accounts. The Accounts and Audit Regulations 2015 require the PFCC and Chief Constable to publish draft unaudited Statement of Accounts signed by the respective Section 151 officers by 31st May and the audited Statement of Accounts by 31st July. However, in response to issues faced by public bodies and auditors from the global pandemic, on 9th March 2021 the government laid regulations amending these deadlines with the Accounts and Audit (amendment) Regulations 2021 (SI no 2021/263). The amendments effectively provided a temporary extension of statutory deadlines to 31st July for the publication of the draft unaudited Statement of Accounts

- and 30th September for the audited Statement of Accounts for production of the accounts covering 2020/21 and 2021/22 financial years.
- 3.3 A full version of the draft Statement of Accounts is due to be presented to COG on 15th June and Strategic Board on 16th June before being signed by the Section 151 Officers of the Chief Constable and the PFCC on 20th June.

4.0 Introduction/Background

- 4.1 The provisional outturn position that these accounts are based on is presented as a separate paper. There is significant accounting work to be undertaken over the next few weeks, particularly in relation to the capital account, collection fund, balance sheet, provisions and pensions and it should be noted that, at the time of writing, there are two unresolved issues which could impact on the provisional outturn and the level of underspend to transfer to the general reserve around Immediate Detriment, in relation to Police Officer Pensions, and Op Allard (On-call back payment claims).
- 4.2 All Command and Departmental budgets have been closed. Corporate Finance are continuing to review the transactions and where there are known outstanding transactions, estimates of these adjustments have been used. Further reviews will be taking place over the coming weeks to ensure financial transactions are recorded in the correct financial year.
