1. Executive Summary

1.1. To seek approval to receive £338,985 from the 2023-24 Home Office Serious Violence Duty (SVD) Fund to use to deliver the work programme for the Essex Violence and Vulnerability Partnership for 2023-24, for activity from 1st April 2023 to 31st March 2024

2. Recommendations

- 2.1. That the PFCC approves the receipt of up to £338,985 Home Office funding to the Essex Violence and Vulnerability Partnership. This funding will be utilised to deliver the agreed priorities of the Essex Violence and Vulnerability Partnership for 2023-24.
- 2.2. That the PFCC signs the Serious Violence Duty Grant Agreement Variation attached as Annex 2.

3. Background to the Proposal

- 3.1. Essex has been allocated £338,985 of Home Office SVD funding for 2023-24, as one of the 20 Violence Reduction Units (VRUs) across England and Wales.
- 3.2. Essex has agreed to utilise this as part of its 2023/24 V&V work programme (which has approval from local partners, members of the Essex Violence and Vulnerability Round Table).
- 3.3. The V&V work programme is overseen by the V&V Operations Board on behalf of the V&V Round Table. The V&V Operations Board report progress against the work programme to the V&V Round Table.

4. Proposal and Associated Benefits

- 4.1. This funding enables local partners across Essex to have a positive impact on issues relating to violence and vulnerability, including drug driven violence, gangs, 'county lines' and exploitation.
- 4.2. This funding supports organisations to deliver on areas of work outlined in the Essex Violence and Vulnerability Framework (2018), the Violence and Vulnerability Business Case (2022) and within the Partnership's work programme for 2023-24, to reduce serious violence and safeguard those being exploited and at risk of exploitation through gangs and 'county lines'.

5. Options Analysis

5.1. The PFCC has the option to reject this funding but that would limit the deliverables of the Essex Violence and Vulnerability Partnership (VVP) and could impact the ability of the VVP to attract future national government funding.

6. Consultation and Engagement

6.1. This proposal has been informed by the Violence and Vulnerability Operations Group and delivers against the activity outlined in the Violence and Vulnerability Business Case approved by the Violence and Vulnerability Round Table in June 2022.

7. Strategic Links

7.1. This funding will enable local organisations to support delivery of the priorities within the Police and Crime Plan, including protecting children and vulnerable people from harm and reducing drug driven violence. It will also deliver against the Violence and Vulnerability Business Case. The funding will be utilised to ensure local partners are able to deliver against the requirements of the new Serious Violence Duty, coming into force in January 2024.

8. Police operational implications

8.1. There are no operational implications. Essex Police is well engaged with this programme at a strategic and operational level.

9. Financial implications

- 9.1. The PFCC will receive £338,985 from the 2023-24 Home Office Serious Violence Duty (SVD) Fund. The PFCC will allocate these funds, according to the agreed 2023-24 V&V work programme. The allocation of this grant is part of the combined Violence and Vulnerability Joint Budget (2023-24) and is detailed in further decision sheets.
- 9.2. The funding will be subject to the funding requirements set out by the Home Office, these will be reflected in the PFCC's funding agreements with partner organisations in the county which deliver elements of the work.
- 9.3. Funding is to be used by 31st March 2024. Any underspend must be returned to the Home Office.
- 9.4. The Violence and Vulnerability Partnership has an agreed programme of work totalling £2,781,000 for 2023/2024.
- 9.5. The combined Joint Violence and Vulnerability Budget (2023/24) is made up of the following amounts,

9.7. To date, from the combined Violence and Vulnerability Joint Budget in 2023/24, there has been agreement or agreement is pending to transfer funding to local delivery partners, as set out below.

10. Legal implications

- 10.1. The award of the grant is subject to the Home Office grant agreement, with data monitoring arrangements outlined as a condition of the Home Office grant.
- 10.2. The Serious Violence Duty Grant Agreement was signed by the deputy PFCC in February 2023. This is attached as Annex 1.
- 10.3. The Serious Violence Duty Grant Agreement has been subject to variation, due to changes at the Home Office Serious Violence team and an amendment to reporting. This grant (variation) agreement is attached as Annex 2.
- 10.4. The grant (variation) agreement, for approval by the PFCC, does not include any substantial changes (from the grant agreement approved in February 2023). The changes are due to changes in the Home Office serious violence structure, with the Serious Violence Duty team now part of the serious violence reduction team and some minor changes to the monitoring requirements in terms of format and how the information is submitted. The changes to the monitoring requirements do not place any additional responsibilities on the PFCC as the accountable body for the fund.

11. Staffing implications

11.1. Monitoring of projects funded from the SVD Fund, as for the whole of the V&V work programme, is supported by the VVU's dedicated Evaluation and Impact Officer, and with support by the VVU's Project Support Officer.

12. Equality, Diversity and Inclusion implications

12.1 No direct implications in accepting this grant allocation.

13. Risks and Mitigations

13.1. There is a risk that funding will not be utilised by the end March 2024 though this is mitigated by early planning, building on the learning to date and by

ensuring organisations are aware of the restrictions on funding and are able to deliver against these. The VVU also monitors other opportunities for funding and if there is any likely underspend can seek approval from the programme's established governance structures to redeploy funding elsewhere if required during the year.

14. Governance Boards

- 14.1. The overall approach to the Essex 2023/24 Violence and Vulnerability Work Programme has been signed off by the Round Table, as part of the V&V Business Case agreed on 13th June 2022. The work programme for 2023/24 (from the agreed business case) was provided to the Round Table at its meeting on 21st February 2023.
- 14.2. This funding supports the work of the partnership V&V programme, which is discussed at various partnership boards, including the Violence and Vulnerability Round Table, and V&V Operations Board as well as internal PFCC meetings. The approaches and activities within the Essex V&V work programme are developed by the multi-agency Operations Board and subject to Round Table approval.
- 14.3. The V&V Operations Board has responsibility for ensuring oversight of delivery of the 2023/24 V&V Work Programme. The V&V Operations Board provides appropriate reporting of progress to the V&V Round Table.

15. Links to Future Plans

15.1. This work supports delivery of the Police and Crime Plan and the multi-year Violence and Vulnerability Business Case.
